The Eugene and Cathy Helbig House is recommended not eligible for the National Register. Although illustrative of settlement patterns in the Oakland area during the mid-twentieth century, the dwelling possesses poor integrity of materials, feeling, and association. Research has not identified any significant associations with historic persons or events. The house neither reflects the distinctive characteristics of a particular architectural style nor embodies the representative work of a master craftsman or method of construction. The building also does not appear to potentially provide important information for the study of history.

The Eugene and Cathy Helbig House located at 552 South Third Street in Oakland stands one story tall in a rectangular plan. The frame dwelling possesses three bays across its main, northwestern elevation and three bays across its northeast gable end. A one-story frame garage sits south of the house.

Constructed in 1940 according to Garrett County tax records, the Eugene and Cathy Helbig House relates to the development of residential areas in previously unsettled areas surrounding Oakland in the mid-twentieth century. Oakland annexed the South Third Street area into its corporate limits in 1989.

The Eugene and Cathy Helbig House (G-VI-A-041) located at 552 South Third Street in Oakland stands one story tall in a rectangular plan. The frame dwelling possesses three bays across its main, northwestern elevation and three bays across its northeast gable end. A one-story frame garage sits south of the house. An in ground pool lies to the southeast of the house and garage. The dwelling overlooks South Third Street, a subdivision of similar mid-twentieth century homes, from the side of a gently-sloping hill.

The dwelling is clad in gray shakes with plain, flat corner boards and rests on a poured concrete foundation. A two-thirds wide gable roofed porch protects the main, northwestern elevation's slightly off-center entry. A closed balustrade connects battered posts rising atop brick piers and supporting the porch's roof. A small gable-roofed entry hood crowns a rear, southeast elevation door. The roofs are sheathed with asphalt shingles and finished with an aluminized cornice and eaves. Two brick chimneys vent the house. An interior pile pierces the center of the ridge while a second, exterior chimney rises along the northeast gable end.

Most window openings contain paired aluminum replacement sash with nine-over-nine lights. A tripartite nine-over-nine penetrates the northwest elevation while an octagonal-shaped window occupies one of the northeast gable's bays. Nine-light aluminum casement windows also light the dwelling's interior. Window ornament consists flat wood surrounds topped by a thin drip molding.

The garage possesses similar grey shingle exterior siding and asphalt roof shingles. A wooden overhead garage door provides entry into the northeast gable end. The garage retains its original three-over-one wooden sash penetrating its southwest gable end.

Constructed in 1940 according to Garrett County tax records, the Eugene and Cathy Helbig House relates to the development of residential areas in previously unsettled areas surrounding Oakland in the mid-twentieth century. Area landowners subdivided parcels along much of South Third Street, then part of the Garrett Highway (US 219's predecessor) and the principal road network leading south of town, during the 1940s. An example of settlement radiating outward from village and town centers along established road networks, development of the South Third Street area evolved during this period in response to Oakland's continuing role as the county's seat of government and the principal market town for southern Garrett County. Oakland annexed the South Third Street area into its corporate limits in 1989.





