The Browning House is a two-story, facade gable roofed frame house with a rectangular main block. The structure has a two bay wide facade and a stone foundation.

The Browning House is related to the expansion of settlement into areas previously located on the fringes of the town of Oakland. The Garrett Highway (the original US 219) entered Oakland from the north via Fourth Street. The home is typical of early twentieth century architecture; the extended survey district boundaries will encompass this pattern of historic development.

The Browning House is located at 316 North Fourth Street on the west side of the road. The property is bounded on the south and west by a line of trees, on the north by a neighboring house and on the east by the road's pavement edge. The dwelling sits approximately thirty feet away from Fourth Street, perpendicular to the road and is built into a slightly rising hillside. A circular macadam driveway on the south elevation provides vehicular storage and egress to the two car garage.

The two story, frame, facade gable roofed main block is rectangle shaped, has a two bay wide facade and has a stone foundation. Projecting from the main block's northwest corner is a single story, frame, one room deep addition. This wing has an asphalt shingle gable roof and sits upon a concrete block foundation. Attached to the west elevation is a single story, frame, shed-roofed addition. This section like the rest of the house has wide eaves and painted wooden shingle siding. On either long elevation, there is an exterior chimney stack; the south wall is cut stone and the north elevation is brick.

Some of the original 2/2 light, double hung sash windows remain while others have been replaced with modern fixed light picture and Chicago-style units. Except for the north elevation, there is a single leaf door on every other main elevation: the facade unit has a single light over three horizontal panels; the west unit has three vertical panes over three horizontal wood panels; and the rear door has nine lights with wooden muntins and surrounds. The two-bay-wide, single story, front porch has three square wood posts, a hipped roof, and concrete floor. A single story, two automobile, frame, facade gable garage is located southwest of the dwellings. Some of its elements include a concrete foundation, two modern aluminum horizontal bay doors, exposed rafter tails, and painted wood shingle siding.

The Browning House, erected in 1918 according to local tax records, relates to the expanded settlement of areas previously located on the fringes of Oakland. Distinguished by development along new and existing roads, these areas were subsequently annexed into the town of Oakland's corporate boundaries. For nearly thirty years between 1916 and 1948, the original US 219 (the Garrett Highway) entered Oakland from the north on North Fourth Street. This home is typical of early twentieth architecture; the extended survey district boundaries will encompass this pattern of historic development.




