High Oaks is located at 434 North Fourth Street. Situated on the west side of the street, the property is bordered on the east by the road's edge of pavement, on the north and south by large oak trees and on the west by an open, green space. The square-shaped dwelling sits back from the road and is on a relatively flat parcel. An asphalt paved driveway is found on the south elevation, becoming a rather large parking area behind the house.

High Oaks, built in 1914 according to county tax records, is associated with settlement expansion patterns in areas previously located on the outskirts of the town limits of Oakland. Characterized by residential development along existing roads, these areas were subsequently annexed into the Oakland corporate boundaries. Before North Fourth Street became a hard-surfaced road in 1916, vehicular traffic traveled this route, the town's northern entrance. High Oaks is typical of early twentieth century architecture and merits inclusion in the survey district boundary extension.

High Oaks is located at 434 North Fourth Street. Situated on the west side of the street, the property is bordered on the east by the road's edge of pavement, on the north and south by large oak trees and on the west by an open, green space. The square-shaped dwelling sits back from the road and is on a relatively flat parcel. An asphalt paved driveway is found on the south elevation, becoming a rather large parking area behind the house.

This two story, ochre-colored brick, truncated hip roofed house has a rusticated stone foundation, an interior brick chimney stack and 1/1 light, double-hung sash windows. Other features include a central projecting section on the second story facade, a dormer on each roof elevation and a full story, four bay, colonnaded front porch and attached porte cochere. Appended to the rear wall is a single story, three bay, frame, shed roofed lean-to addition. It is covered with weatherboard siding and it rests upon a brick pier foundation. Except for the rear shed dormer, the remaining three dormers are gable roofed with the facade dormer exhibiting a Palladian window treatment and a turned cornice. The altered front porch is missing its original raised wood platform and the replacement vinyl coated fluted columns seem elongated and entirely out of scale and proportion to the facade.

The original fenestration has been retained, the majority of the units are 1/1 light, double hung sashes. The facade exhibits the most variety with cottage windows with upper leaded lights on the first floor and a triple unit in the central upper story space with upper stained glass sashes. In the northern wall plane, a centrally located oriel window has three vertical fixed lights, two of which have stained glass. The single leaf front door is surrounded by a leaded glass transom and side lights while the side doors have four upper lights above wood panels.





North 4th Street
