DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This five bay, two story home is located in Norrisville very close to the state line. The house presently faces north and consists of two units. The first unit, on the east, is three bays long; the other unit is two bays.

The house is covered with asbestos shingles on the north facade and the west facade. Clapboard covers the east wall and the second elevation of the south facade. The first elevation of the south facade has been exposed to reveal log beams. The gable flank roof is covered with tin. It has a box cornice. A corbeled brick chimney is located between the two units. Both units are built into a slope with the rubblestone foundations visible on the south facade. These entrances consist of beaded board and batten door, each one is pegged. Entrances on this facade's first elevation are onto a one story shed roof porch which runs the length of the house.

Doors on the north facade are fairly new and are located directly opposite from the doors on the south. Windows are six lights over six and have louvered shutters.

The ground elevation of the east unit consists of one large room with large stone cooking fireplace on its west wall. This has an iron crane in it, scored with "x's" to form a decorative pattern. Wood beams are visible in the ceiling. Walls are plastered. The door on the south facade has iron strap hinges. A winding stair is located in the northwest corner next to the fireplace. The first elevation and second elevation are broken up into many small rooms. At the attic level there are pegged beams. The attic room is well lit, having two 2/2 windows flanking a center 4/8 window.

The western two bay unit also has a room on the ground floor. This has a dirt floor and log beams are visible on the ceiling. Iron strap hinges are on the diagonal pieced door. This room was probably always used for food and other storage. It has no stairway leading to the upper levels of the unit. The first elevation of this unit is a modern kitchen. The east wall has been stripped to reveal the log beam construction of the house. An enclosed stairway is located on the west wall. The second elevation had originally been cut off from the second elevation of the east unit. There had been no passageway on the second elevation until the present owners cut one through.

STATEMENT OF SIGNIFICANCE

This log dwelling is significant for its architectural individuality. The two log units, representing different periods of construction, stand touching, however, each has separate entrances and interior passages between the two units were not added until very recently.

The names of owners in 1798 and 1814 could not be found on the tax lists for those years, Eden Hundred's assessment for 1798 being incomplete and nearly illegible.

The eastern, three bay unit of this house appears to be the older of the two. Built into the side of a hill, it originally faced south, probably to take advantage of the prevailing westerly winds in Summer and of the heat furnished by the Winter sun. Houses built on side hill sites had the added advantage of an upper and lower ground level, the upper of which was not taxed as a separate story. The kitchen is on the ground level.

A frame house, clapboard covered with asphalt shingles over that ~~on~~ the north side of the house. ~~Unaltered~~ The farm house sits back from the road and is sheltered on the south by several maple trees. 5 bays by 2, 2 stories high ~~unaltered~~ on a stone basement. On the south, there is a cooking fire place in the west end of the basement. Facing north, the roof ridge runs east-west. The ^{slate} roof has narrow eaves and no trim. A chimney rises from an interior wall to the peak about $\frac{2}{5}$ of the distance from the west end wall. Owners say the posts are log. Window frames are pegged.

Two farm buildings are noteworthy. The timbered barn, L shaped, is very large, with board and batten cover. The mow, are lighted with $\frac{2}{2}$ Palladian windows high in the gable end of either end wall of the main section. And a ~~the~~ the roof is of slate.



