DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This spacious farm house, frame clapboard, is T sloped, 2 1/2 stories, 3 bays by 2 with 3 bays by 2 in the wing. Facing north, the ^{slate} roof red gable runs east-west, the wing running south from the center of the house. A peaked dormer is large enough to form a gable over the front door. Windows have 2 lights over 2, with the dormer window pointed. There are three chimneys, ^{inside} one ~~at~~ each end wall.
