This small frame house has asphalt shingle covering ~~the~~ clapboard. Facing east, 3 bays by 2, 2 stories high, oblong, the slate roof/ridge runs north-south. Built in the bank over a stone basement, another half-story is found on the ~~west~~ ^{east} side of the house, facing the valley. A two story porch has a plain ~~bannister~~ ^{rail} (with narrow square bannisters) on the main floor level on the east. Chimneys rise in either end wall.
