STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

This schoolhouse was built over on a house, probably about 1880. Once located part of the main road south to Bath Free Ferry on the Susquehanna, this structure may remain from those days when this ferry was in use before the Consowingo Bridge was built in 1820 about six miles downstream.
