DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This 2 story, coursed stone house is set back off Calvary Road (MD 136) directly across from the Calvary Methodist Church. The house faces north east and consists of two main sections forming an L shape. Windows in each of these sections are six lights over six. Some of the panes have been replaced. All windows have stone lintels. The roof in each section is gable flank and covered with slate.

Section one of this house is five bays by two. It has a gable flank slate roof with a corbeled brick chimney at each inside gable end. The roof has box cornices with dentils on the north east facade. The principle entrance is in the center bay on the north east facade and forms a through hall with the entrance on the south west side. This entrance, though the door remains on the interior, is blocked up on the exterior. These two main doors are original and have four moulded panels on each. Box locks are also present on these doors. The north east entrance has a four light transom overhead and a slate step. A one bay, one story, gable front, pedimented porch has been added to the principle entrance in the 1950's. Before that, a wrap-around porch had been present.

The south east facade has been changed by the present owners to accomodate their needs. Originally, this side had one window on each elevation located at the south bay. The owners have changed the window at the first elevation into a door and have added a window on the same elevation. Much attention has been paid to detail in this alternati and the changes blend in well with the character of the house. A datestone is located between the second elevation and the attic on this side. It reads: 1770, I:M:A:D, Pity-Liberty. Two attic windows flank the chimney on this side, each consisting of four lights.

On the north west facade, four light attic windows flank the chimney. No other doors or windows are present.

Inside, this section has been altered to provide a more comfortable home. A fire place in the north west room has closed up so that is chimney could be used for the modern heating system. Many of the rooms have been paneled because of the difficulty the owners have had in keeping paint on the walls. The through hall, however, remains plastered. Space in the south east room has been decreased by the addition of a cupboard and a bath-room. A brick fireplace in this room has been repointed and many of the bricks are replaced. Panes of glass in this section are very old and one has the initials "BMD" carved on its surface. The stairway, located in the through hall, has a turned newel post. The rounded hand rail fits into the newel post in a "V" fashion. Rails are square; risers are low.

The second section is three bays long and consists of one room. Many changes have been made on the interior. Walls are paneled and a door located on the north west has been turned into a cupboard. On the south west wall there is a large brick fireplace with a granite keystone. The fireplace has a crane. An enclosed stairway is present next to the fireplace but it has been closed and a cupboard is present where an entrance once was. A frame kitchen was added to the south east side in the 1940's.

The house has a cellar under Section 1 only. In this basement, fireplace supports are visible.

STATEMENT OF SIGNIFICANCE

This rubble stone house is situated on portions of the tract Christopher's Camp and was probably an early Webster family homestead. This is, however, difficult to ascertain through title search as it was impossible to get beyond 1841. Mention had been made in the title search of Buena Vista (HA-1056) of a Webster house being located slightly west of that dwelling and the Adams house is assumed to be the same house as mentioned.

The house is of simple design with a classic central hall floor plan. An el, though probably an addition, appears very old as well.

This house and farm forms with other structures in this area a small, historic farming community. It forms with other fine, old structures such as Buena Vista (HA-1056), Howard's Forest (HA-1059 and 1060) and the Calvary Methodist Church (HA-997) the Creswell/Calvary farming community.

This property is within the Maryland Rte. 23 extension study area and one of the proposed route alternates would dissect portions of this farm. The house and farm should therefore be considered as an important feature expressing the character of the County before any decision on an alternate route is made.
