This very plain frame farm house, clapboard covered, is L shaped. Facing east 3 bays by 1, the wing runs west along the north end wall 2 bays by 2 (down stairs) (upstairs 2 bays x 1). Two stories on stone foundations, the A-frame roof/ridgepole runs north-south. There is one chimney only, inside the west end wall, a flue for stove heat and cooking.

A one-story porch shelters the east side down stairs, while a kitchen porch over from with pipe river leads to a hand pump over the well, still in use.
