An above grade veranda extending across the front and around the side of the house is typical of its era. It is one of several dwellings in Havre de Grace built in the late 19th or early 20th century in a vernacular second Empire Style.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

212 S. Stokes Street is a nearly square two story frame house with a Mansard roof. The house (c.1890) is three bays wide and four bays deep, with a two story two bay wing under a gable roof on the rear. Covered with clapboard, the house is painted white with green trim. An ashlar granite foundation underlies the entire structure. Facing east on south Stokes Street, the house has a spacious yard on both sides and is in excellent condition.

An above grade eight bay veranda extends across the front and south elevations, with a flat roof that is supported by bracketed posts. The railing has perforated designs in it. Lattice work fills the spaces between the brick piers that support the porch.

Windows are spaced evenly on the facade. All of the windows have 1/1 light double hung sash with wide board enframements flanked by louvered shutters. Two dormers, crowned with bracketed flat roofs, are in each elevation of the Mansard roof. A two story bay addition is on the rear of the south elevation.

A threesided glass and wood enclosure extends from the north bay. Behind it is the front door, having glass in the upper panel.

The main section has a high asphalt covered Mansard roof with two windows on each elevation, while the wing has a gable roof. A chimney is on the northwest end of the roof, main section.

Two large outbuildings, one a garage, are at the rear of the house.
