DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

814 Market St. is a two and a half story, four bay (on the second floor) wide frame Federal dwelling on a low lighted stone basement. Rectangular in shape, the house is a single family residence in the process of renovation. It faces east on Market St. with an unobstructed view across an empty lot to the Susquehanna River emptying into the Chesapeake Bay. The house is covered with asbestos shingles, painted white.

The house has a brick stoop on the front and north elevations, and a two story porch with fence railing and square pillars is on the rear.

Windows are spaced evenly on the facade. Throughout the house they have 6/6 light double hung sash. The upper sashes of the dormers are arched.

The present main entrance is in the center bay front elevation. Both the plain pilasters and pedimented hood framing the door (modern) are recent additions. In the center of the north elevation is a door with almost identical framing to that on the front; it has a door with two horizontal panels, having glass in the upper half.

The house has an asphalt shingled gable flank roof with pedimented dormers on the front. A large brick chimney, having new brick on the east side, is on the south end of the roof. The owners believe there was a chimney on the north end also. The roof has overhanging eaves with exposed rafters.

Interior: The house has been altered considerably and the owners feel that it was a double house not to long ago and perhaps originally. In the attic, there are hand hewn beams, charred and supported by 2' x 4's. Marks of cross beams are visible in the charred beams which give evidence for a fire. The south wall of the basement retains a cooking fireplace with a raised hearth and a rectangular opening. Above the basement fire place, on the first floor is a fireplace with a small rectangular opening, the brick around it having been recently exposed and repointed.

A spacious yard is at the rear of the house.

STATEMENT OF SIGNIFICANCE

814 Market St., a two and a half story frame house built in a vernacular Federal style, appears to be one of the oldest houses on Market St. It has a random rubble foundation, a cooking fireplace in the basement and the roof, probably replaced after a fire, has pedimented dormers on it.

Although the history of the house is not known, the name Day appears at the site on a 1858 map of Harford County. Finally, the site of the house is important; it is one of the very few in Havre de Grace with a an unobstructed view of the Susquehanna River as it flows into the Chesapeake Bay.


