DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

100 N. Washington St. is a three story, three bay wide Italianate frame commercial building, located on the corner of N. Washington St. and Congress Avenue, facing east. A two story clapboard dwelling with several additions on it joins the rear wall and a two story frame commercial building abutts the north wall. Constructed in the 1880's, the building although covered with aluminum siding, is remarkably unchanged.

On the first floor there are two and four light (pegged sash) polygonal display windows with slightly arched upper sashes which have under them, molded wood panels on low ashlar granite foundations. The display window on the north side is three sided while the one on the south is pentagonal, wrapping around the south elevation. Slender applied columns mark the division between the bays and all of the fenestration is topped with a wooden cornice, having small Eastlake flower designs pierced in it, which has an upward slant. The entire cornice is presently covered by a sign with the store's name in it. The second floor windows have 1/1 light sash, while the third floor has 6/6 light sash. The first floor window on the south elevation contains two windows of 1/1 light sash each, with arched sashes, held within a single rectangular frame. The other upper story windows are consistent with those on the front elevation.

The main entrance, flanked by heavy brackets, is in the center bay, front elevation. A slightly arched enframent contains a glass door, framed with wood, and having a one light transom with a air conditioner in the middle of it, above it. In the space above the transom is an arched panel with a floral design incised in it.

The roof is flat with a wide bracketed cornice and no chimney is visible.

STATEMENT OF SIGNIFICANCE

The Asher Building, a three story frame Italianate commercial building looks today much as it did when it was constructed in the 1880's. It display all of its original exterior trim and woodwork including polygonal display windows with molded wooden panels on a low granite foundation below them. The retention of wood in this store front is noteworthy because so many shop fronts have had their orginal wood panels replaced with brick. Presently a large metal sign covers the East-lake cornice over the windows; the cornice is incised with floral designs.

The building is located in a block which is strong on 19th century architecture and has few intrusions. By location it is crucial to the preservation efforts of the City; it is not only a corner building, whose appearance affects two street scapes, but it is the last building on the west side of N. Washington St., before it becomes S. Washington St. and residential.


