DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

825 Market St. is a two story two bay wide frame dwelling located on Market St. facing west. A vacant lot, the result of land fill after a hurricane in the 1960's, is on the north and The Bayou Hotel property, now owned by the City of Havre de Grace, is on the south and southeast. The land behind the house-terraced and planted-runs to the Susquehanna River at the point where the river flows into the Chesapeake Bay. A two story frame addition on the rear with a one story addition on its rear wall gives the entire structure a T-shape plan. The house is covered with weather boards and painted white with green trim. It is thought to have been built in the late 1850's.

A six bay veranda extends across the front and around the south elevation, main section. It has a shed roof supported by tapering pillars and a fence rail balustrade.

Windows on the front elevation have 2/2 light double hung sash flanked by louvered shutters. Most of the other windows in the house have either 2/2 or 2/1 light sash. A modern three part bay window has been added to the first floor south elevation of the wing.

The main entrance is in the north bay, front elevation. The door, half paneled half glass, has a one light transom above it.

The main section has a slate gable flank roof while the wing has a lower gable roof with the ridge perpendicular to the main block.

Outbuildings: Two vertical board outbuildings are in the rear.

STATEMENT OF SIGNIFICANCE

The De Groat House, a well maintained two story two bay wide frame house under a slate gable roof, has a rear wing with several additions on it. The 1858 Herrick Map of Harford County shows a house on this location, with the name J. Boyd beside it. The main section of the house is believed to date from the 1850's, although it appears to have been built later. The location of the house is outstanding. The owner's finding themselves on a busy street, near Tyding's Park (which becomes a congested area on the weekends), have assured privacy by planting extensively all around the house and orienting their activities, flower and vegetable gardend etc., to the rear, where the ground is terraced as it descends to the Suquehanna River, (at he point where the River flows into the Chesapeake Bay.) The south side of the De Groat property is bordered by the Bayou Hotel grounds. (HA-1127)


