The Arthur Hannon House dates from at least 1914 when it was purchased by Edward Moores, owner of a mill. The 84-acre farm comprised parts of the tracts "Pittsburg," "Outlet," "Prospect," "Wood Orchard," "Hazzard," "Cudgel," and "Cooper's Park."

The two-story, e1-shaped clapboard house, five bays long and one room deep, has an interesting orientation: with the long side of the e1 parallel to the road, the house appears much larger than it actually is.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

0A Located on the north side of Prospect Mill Road, between Thomas Run and Fountain Green Roads, this el-shaped frame house is unusual in that the long side of the el fronts the road. The front section covered in shiplap and set on a stone foundation appears to be the more recent of the two parts and is five-bays long and one room deep. The west side of the rear one bay by one bay addition is flush with the west end of the front section. The windows in the latter have 6/6 sash; those in the front have 2/2 sash (except for one which has 6/6 sash). There is a brick chimney in each end and two porches on the main section: a hip-roofed, five-bay long front porch with square posts, and a shed-roofed one along the back. On the west side of the rear addition is a new, shed-roofed one room wing.

The front facade has a central door flanked by two windows on each side, with corresponding windows in the second story. The ends each have two four-light gable windows, but the west end has two windows in the second story and one in the first, while the east end only has one in each story.

The rear wing has a door in the first story and a window in the second story of the east side, a single window in the first story of the north end, and in the west side, one window in the second story and a new one south of the addition.

STATEMENT OF SIGNIFICANCE

This unextraordinary late 19th or early 20th century structure was constructed at least by 1914 when Edward P. Moores, son of John Moores, sold his share of the home farm for this 84 acre farm when he was married.¹ This one was "improved by buildings" and consisted of parts of the tracts "Pittsburg", "Outlet", "Prospect", "Wood Orchard", "Addition to Woods Orchard", "Hazzard", "Cudgel", and "Cooper's Park".

Edward Moores, son of John Moores, inherited his father's mill when he died in 1911.² John Moores had owned more than 390 acres in this area. His great-great grandfather, James Moores, had purchased the nearby tract "South Hampton" and was a tanner, using a sawmill for cutting and removing the bark from oak trees to use in tanning leather.
