The Webster-Cassilly house was built in 1886 by George S. Webster on a 131-acre farm that had previously belonged to his uncle, also named George S. Webster. The wing on the east may belong to the earlier George Webster's house--he lived on this farm until his death in 1847.

The side hall plan and German siding are somewhat unusual for this rural and rather insulated area, where people generally preferred the old standby - clapboards and at least the illusion of a central hall plan. (Houses with central entrances, however, sometimes contained just two rooms on the first floor with a central staircase against the inside wall of the larger room.)

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This early to-mid-19th century, gable-roofed frame house consists of four parts, which may or may not have been constructed at separate times. The two-story house covered in shiplap and set on a stone foundation is block-shaped and faces south. The main or south section is three bays wide and one room deep; the north part consists of a one bay by one bay portion with a central brick chimney with a molded cap and a one bay wide extension on the east that fills in the el. Adjoining the latter is a one-story wing with a large plain brick chimney in the east corner of the north flank of the gable roof. Except for the windows in this wing which have replaced sash, windows have 6/6 sash and louvered shutters. Gable windows have four lights. Corners of the house are decorated with pilasters.

On the south or principal facade, the door is in the east bay and flanked by two windows on the west. Windows in the second story are aligned with the openings in the first story. The entrance door has four panels and a two light transom. The porch, with a cyma recta cornice and square posts, appears to have been lowered.

The east end is blank except for four-light windows in the gable and first story. The west end has one window in each story.

The north section-slightly indented from the south section-has one window in each story of the western flank and a door in the first story and window in the second story of the north end. These are flanked on the east by one window in each story of the eastern extension. The east side of the latter has two windows in the second story.

STATEMENT OF SIGNIFICANCE

This house may be the "comfortable" house built in 1886 by George S. Webster on a 131 acre farm that had previously belonged to his uncle, George S. Webster.

Described in his biography as "well-to-do and not obliged to work unless he so desires", George S. Webster, born November 27, 1825, was the son of Henry Webster. He attended the academy at Churchville, which was built by his father and Mr. Finney. He then attended school in Kent County and eventually purchased two farms in Harford County. He sold one in 1865 and lived in Bel Air with his brother, Col. Edwin Webster, for 17 years after his father's death in 1872.

The present house may contain-or be on the site of-an earlier house, listed in or near this location on the 1858 Jennings & Herrick Map as belonging to G.S. Webster. George S. Webster purchased 131 acres of "Stony Ridge" for \$650 in 1816.<sup>1</sup> The parcel was valued at \$1000 in 1847 when he died, leaving his property to the daughters of his mother, Henry Webster.<sup>2</sup> His inventory reveals that he had a 150-acre farm (in two separate tracts) and a frame dwelling house in fair condition, a small barn, a hen house, and a shed, all together valued at \$2100.

His nephew, George S. Webster then purchased the 131-acre farm in 1859.<sup>3</sup>
