The Strawbridge-Edie House was built by Henry Strawbridge after 1868 when he acquired a 106-acre farm from Joseph & Lavinia Mulinix. The farm included part of the tracts "Hughes Cabin," "Brown's Choice," and "Heidleborough."

At least one feature of this farmhouse should be noted. The principal facade contains two entrances, presumably "formal" and "informal," yet the second floor fenestration is asymmetrical. Generally, the distinction between public and private evinced by the two front entrances was also reflected in the difference between the front and rear facades. The former would be neatly arranged and relatively formal; the latter would be comparatively haphazard with windows and additions arranged irregardless of external appearances.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story, gable-roofed frame house is located on the north side of Bradenbaugh Road, between Norrisville Road (Md. Rte. 23) and Harford Creamery Road.

Set on a slope with a raised stone foundation, the house is now covered with asbestos shingles and has two interior end brick chimneys. Facing south, the three bay wide and two bay deep house has a one-story, 4 bay-long, shed-roofed addition spanning the north side. except for the four-light gable windows, windows have 6/1 sash and plain trim.

The principal or south facade is spanned by a one-story shed-roofed porch with square posts and a railing with square balusters. The porch is reached by a flight of steps at the west end, and the foundation has been enclosed. Entrances are in the center two bays of the first story, with windows in the two outerbays. The three windows in the second-story are arranged asymmetrically.

The east end has one window in the south bay of the first-story and two gable windows.

The west end has two windows in each story.

The interior of the main section has a two-room plan with a winder staircase in the northeast corner. The basement has log joists, a fireplace in the east wall and in the south wall are exposed portions of brick. The original clapboard siding is visible here.

STATEMENT OF SIGNIFICANCE

This house is said to have been built by Henry M. Strawbridge, who acquired a 106 acre parcel of land for \$1500 from Joseph & Lavinia Mulnix in 1868.¹ This farm included part of the tracts "Hughes Cabin", "Brown's Choice", and "Heidleborough". Seventeen years later, in 1885, Henry Strawbridge purchased a 25-acre lot for \$707.26 from Benjamin Ayres, which had previously belonged to his father, Thomas J. Ayres, Sr.² The latter was one of the large landowners of the area, and Benjamin Ayres has been described in one biographical sketch as one of Harford County's leading agriculturists. This house was constructed on the lot purchased from Joseph Mulnix, although it does not appear on the 1878 Martenet's Map.

In 1902, Henry and Elizabeth Strawbridge sold the 131-acre farm to Ralph and Margaret Edie for \$3000³, and it has been owned by the Edies since then.

At least one feature of this farmhouse should be noted. The principal facade contains two entrances, presumably "formal" and "informal", yet the second floor fenestration is asymmetrical. Generally, the distinction between public and private evinced by the two front entrances was also reflected in the difference between the front and rear facades. The former would be neatly arranged and relatively formal; the latter would be comparatively haphazard with windows and additions arranged irregardless of external appearances.
