This stone set in the pavement near 33 Courtland Street is one of two remaining stones which marked the limits of the County lot when the Town of Bel Air was laid out. The other is in the curb at the southeast corner of Office Street and Bond. Together they marked the northwest and southwest corners. They have been used as surveyors' benchmarks since they were put in place.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Survey Stone #2 is located on the Courtland Street side of the corner of Courtland and Bond Streets in the Town of Bel Air, Harford County, Maryland. It was apparently originally tombstone shaped, but it has always been just a rough stone. Over the years it has been fractured and is now only a stump, 1'3" high and 4'7" in circumference.

STATEMENT OF SIGNIFICANCE

Survey Stone #2, one of four stones that were one at each corner of the County lot in the Town of Bel Air, is one of two remaining on the original site. Survey Stone #1 is one block north in the curb at Office and Bond Streets. The easterly two stones have disappeared under the blacktop of the parking lots behind the County Building and Courtland Hardware.

These stones have been used as surveyor's bench marks since 1782 when the Town was laid out.






