This five bay store front with Queen Anne upper windows and a handsome bracketed cornice is the result of a rationalization of the facade in the 1940's. The original structure had a three bay store-front to the north and a two bay residence setback from the street to the south. The cornice and brackets are original. The three bays to the north served as the engine house. After Louis Hollander bought the property in 1941, he had the present facade built for his home and auto supply store.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This five bay storefront is at 34-36 North Main Street in the Town of Bel Air, Harford County, Maryland. It received its present form in 1942 (see #8 for the former configuration). The east (front) elevation is covered in asphalt shingles in the second story. It has a thin cornice supported by decorative brackets and five windows in plain surrounds. The tops of the double-hung sash windows are composed of one large pane surrounded by long thin panes with square panes in the corners. The bottom half is two long panes. The first story front has an art glass panel over plate glass windows slanted in toward the entrance. In the southernmost bay of the first story is the entrance to the second story rooms: a two pane transom over a door with two long glass panes and a paneled bottom.

The north elevation shows how the building has grown. Two easterly bays are shiplap and original. The other hundred feet is cinderblock, two bays single story and two more bays two story (from east to west). A six panel garage door occupies the most westerly bay.

SPECIFIC DATES 1889 BUILDER/ARCHITECT Lingan Brothers

STATEMENT OF SIGNIFICANCE

This Victorian storefront was built in 1889 for Octavian and Aquilla Whitaker on land they leased from Hortense Jeffrey (1887, 58/341). Lingan Brothers built it for \$2,143. From that time until 1941 it was in two sections, a two story store 19' x 16', and a dwelling 18' x 32' with a backbuilding 14' x 16'. Old pictures show the house as having its front wall level with the house next door (The Graham-Crocker House, 30 N. Main). It was a three bay structure with a shed-roofed porch carried on chamfered posts with carved brackets. A series of decorative brackets supported the cornice topping the second story. The store (to the north) was around five feet closer to the street. It was also a three bay structure with decorative brackets supporting a second story cornice. In 1904 a steam laundry was in the store. Edwin F. Hanna of Delta may have had a clothing store there in 1891.

In 1924 the property was sold to the Bel Air Volunteer Fire Company (186/344) which moved there from Courtland Street. In this incarnation the shop became the engine house. A 1924 photo in the Bel Air Centennial Book shows the shop front gone but the bracketed first story cornice still there. The Fire Company sold the property to Louis Hollander in 1941 (269/491). The Fire Company moved to Bond Street and Hollander opened his home and auto supply store after alterations which gave us the present five bay structure. The old windows and cornices and brackets were used to give a unified facade. Hollanders stayed there until the shop was moved to Campus Hills Shopping Center in 1977. The building is now the property of Joan, Jennifer and Robert Ward (1079/614) and is vacant.




RESOURCE SKETCH MAP
