DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This stone house is located at the end of a long lane off Coolbranch Road in Churchville. The 2 story house faces south and is 3 bays by one. It has two frame additions. The gable flank roof is asphalt covered. It has box cornices. One corbeled brick chimney is located at the center of the main structure on the north side of the roof. The principle entrance is in the center bay on the south side. The door is inset and is wood plank held together with pegged girts and braces. Windows are 6 lights over six granite lintels. A 3 bay, screened in porch built onto a concrete base is located on the south side. It is one story high and has a shed roof. The west gable end bears a date stone of above the attic window. Between the second story window and the first story window, there is an ornate, cast iron door. Its use is not known but the owner mentioned that a pipe inside the house had been hooked up with it. The door opens to the outside.

A one story frame addition located to the east of the main structure is L shaped and 3 bays long. Windows in this section are 6 lights over 6.

A two story, frame addition on the south side of the main structure added a kitchen and extra bedrooms to the dwelling. This addition is fairly recent.

This house has burned twice and most of its interior features have been destroyed. A few charred beams are visible in the attic but most of the roof structure had to be replaced after the last fire. The fire place in the 1st floor of the main structure has like wise been altered.

The main structure does not have a cellar but there is a small crawl space under part of that section.

STATEMENT OF SIGNIFICANCE

This stone house, situated on the tract Hall's Rich Neck, bears a datestone of 1860. This simple farm house has one unusual feature. Between the second story, window on the west gable, is an ornate, cast iron door. The present owner stated that heating pipes had been connected to this opening but this seems a strange ventilating system.

The tract, Hall's Rich Neck, was patented in 1699 by John Hall, the owner of many large tracts in Harford County, including Cranberry Hall. By 1783, the Maryland Tax List shows that Thomas Hall owned 652 acres of the original tract. In 1798, Freeborn Brown is shown as the owner of part of this tract. The presense of many buildings on the property at that time seems to indicate a fairly successful farm. Present in 1798 were a two story stone house, a granary, a brick house inhabited by his relative, William Brown, a brick kitchen, a grist mill, a saw mill and house.




