This is the earliest known front gable Victorian house in Town; it may, therefore, be the type house for all those that followed. While all the Town copied the front gable, very few copied the wide eaves with exposed rafters, a mid-Victorian idea of "authenticity" in construction.

The house has been nearly engulfed by a one story brick office addition.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two and a half story ship-lap Victorian house with a gable roof is at 124 N. Main Street in the Town of Bel Air, Harford County, Maryland. It is T-shaped and has had a one story brick and concrete block addition built in front of and around the sides of the main block. Remaining visible are the front gable with exposed rafters and the 2/2 double hung sash windows with molded window hoods. The front and side gables have 4/4 round arched windows. The windows of the three bay back building are 6/6. Two corbel capped chimneys are also visible, one at the join of the front and back buildings and one in the ridge of the back building about 2/3 of the way back (east). A shed-roofed side porch on the south elevation of the back building has been enclosed and another, flat-roofed, addition has been added south of that. A small shed-roofed addition is on the rear (east) elevation of the back building.

The front addition is brick with a plain cornice and narrow slit windows. The door is of glass and aluminum.

STATEMENT OF SIGNIFICANCE

This mid-Victorian house, now engulfed by a one story brick and concrete block building, was originally the usual three bay two story house with a front gable. It was unusual in having slightly exposed rafters in the front gable, a legacy of early Victorian ideas about authenticity, but unusual in Bel Air. It is also unusually early for this style in Bel Air and may be the type house for dozens of similar houses built between 1870 and the first World War. It was built in 1865 or 1866 by Mrs. Elizabeth Walker on land she bought from Charles W. Lee in 1865 (16/350). In October 1866 she sold this house to the trustees of the Methodist Protestant Church for \$3,000 (18/67) and bought the Methodist Protestant Parsonage (now demolished) on the corner of Main and Churchville for \$2,500 (18/68). The house appears on the 1878 Map as the residence of Reverend Swentzel and the office of J. B. Swentzel, a dentist. After the Masons built their new lodge on Wall Street, the Methodist Protestants built a church south of this parsonage (c. 1885). The parsonage was sold in 1965 to Charles L. Lutz (695/277) and has been put to various commercial purposes since. It now belongs to George E. Campbell. It and the front addition now house medical offices.




