DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This T-shaped shiplap sided house is on the east side of North Main Street at #139 in Bel Air, Harford County, Maryland. From the street, the house has the appearance of being L-shaped, but what looks like the ell has had a further addition on the back, making the house roughly T-shaped. (The addition was made after 1904.) The elegance of the front elevation can be attributed to the three-sided bay window on the ell, by the carved hoods supported by brackets over the windows of the bay and the two second story ell windows, by the shutters to all the windows, and by the porch and the positioning of the entry in the angle where the ell and the main block meet. The porch is supported by three Roman Doric columns, the southwest one free-standing, the other two engaged. The windows in the pre-1904 house are 4/4 double-hung sash, all but those on the front of the ell set in plain wooden surrounds. The gable roof (or roofs, since there are three ridge lines) is covered in asphalt shingles. A shed porch behind the house has been enclosed, and a separate enclosed, gable roofed entry to the back apartment occurs in the second west bay of the north elevation of the post-1904 addition.

The interior has been somewhat changed by renovation into apartments, but the woodwork and elaborate moulded cornice of the room in the ell look original. The non-operative "Gothic" fireplace is probably not. It has a Tudor arched opening, carved greyhounds in the spandrel, a row of quatrefoil roses in the frieze and Gothic columns engaged up to and through the mantelshelf. It seems to be made of plaster or some composite "stone" material. It has electric logs. The room to the south across the triangular entry may be more or less original. A large mirror with a gilded frame, original to the room, occupies the space between the windows in the south wall. A dressing table with a skirt has been added to the bottom of the mirror. The room is now a bedroom. This may have been the parlor with the room in the ell being the dining room, but the floorplan has been so changed that it is difficult to tell. The staircase is now enclosed and leads from the middle of the entry.

If the moulded cornice and the gilded mirror are any indication, the interior was once quite elegant.

Access to the upstairs and to the back apartment was not available.

STATEMENT OF SIGNIFICANCE

This pleasant vernacular house, like most of Bel Air's older homes, vaguely Victorian, is one of the few remaining residences on Main Street. It, with the Hopkins House to the north and the Maynadier House to the south, form a domestic looking enclave in the northern section of Bel Air's business district. It is the only one of the three which is still a private residence, and it has been turned into apartments.

The Norris House was probably built by Charles Bouldin between 1869 and 1872, but might have been built four or five years earlier. Charles Bouldin and his wife leased the lots on which the Hopkins, Norris, and Maynadier Houses stood in 1861 from Charles Lee for \$50 a year. They bought the lot, which had a 208 foot frontage, in 1869. By that time they had built the Maynadier House (129 North Main) and were living in it. They sold this portion of the lot to George Jeffery in 1872 for \$1600. (27/324). For that price it must have had a house on it. Jeffery lost it to a series of defaulted mortgages totaling \$1700 in 1875, and Joseph Street sold it to John S. Dallam in February, 1875. The mortgages date from shortly after Jeffery bought it in 1872, and they show buildings on it at that time. Dallam returned the property to Street a couple of weeks later for \$1700 (31/264). The Streets sold it to Charles W. Norris, a Bel Air merchant, in 1876. At that time the lot had improvements on it, and the Harford Democrat for that week tells us that Norris was moving the house back from the street. He may have done more than that. The Norris house is a more elegant house than the Maynadier house Bouldin built for himself. Bouldin had also built a house on the Hopkins House lot next door, a picture of which is in the Hopkins House file. It was also a simple house. Norris may have added the bay window and the bracketed window hoods at the time he moved the house, or he may have added the entire north ell, for when he, in turn, lost the house (1880, 41/232) it sold for \$2650. (Norris also lost his store property at the same time. Possibly he overextended himself when he enlarged the store property - the Jarrett Buildings on South Main Street - in 1875). George Van Bibber, the trustee for the sale, advertised the properties in the Harford Democrat for January 9, 1880. The house was described as being a new two story frame dwelling having nine rooms which would correspond to the house's 1904 configuration. Unless he demolished the old house, the house, or portions of it, must have been around ten years old. Nevertheless, since the newspaper calls it a new house,

it is possible Norris tore down the old house and built anew. His renovations (or building) may have been done by Bel Air's master builder, Jacob Bull, for it was Bull who did the renovations on the store. Van Bibber sold the property to Sarah M. Shepherd, whose heirs sold it to John C. Butler for \$3025 in 1893 (75/305). Butler sold it to Joseph T. Deckman, a prominent Harford canner and Bel Air property owner, in 1904 for \$4205 (108/481). Something major went wrong with Deckman's finances in 1911, and he began selling property all over town, including this property where he and his wife, Florida, made their home. This house went to Thomas C. Forsythe for \$2,000 (134/197), clearly a sacrifice price, for he turned around and mortgaged it for \$4125 within weeks. The deed makes no mention of it, but Deckman may have owed Forsythe money, or he may simply have been desperate enough for ready cash to sell it at half its worth.

In May, 1917, Forsythe lost the property to the defaulted mortgages, and it was sold to James T. Smith (155/306). Smith sold it to George W. Johnson for \$5500 in 1919 (166/462), and Johnson sold it in 1921 to Retta Peterson for \$6500 (173/3). Peterson and her husband sold it to F. Lee Hughes for \$7300 in 1925 (195/76). Sometime between 1904 and 1925, the final addition was made to the northeast portion of the house, likely after 1919 by the Johnsons, which would account for the mortgage they took out on the house. The house increased in price by around \$800 when the Johnsons bought it (1919), when they sold it (1921), and when Hughes bought it (1925); any one of the increases could have paid for the two story addition. The selling price took a nose-dive in the depression when Simon Getz bought it from a trustee for \$3200 (1933, 225/532). It has remained in the Getz family since that time. Simon and Kate Getz probably lived there, because the door knocker has the name "Getz" on it. It is now the property of Marvin and Payson Getz, and has been made into three apartments.







The Bouldin family was prominent in Bel Air for nearly a century from 1830 to 1920. Charles D. Bouldin and his sons, William, Richard, Robert, and Charles H., were leaders in politics, journalism, commerce and medicine. Among them they owned and edited eight newspapers from 1830 to 1871, seven in Bel Air and one in Towson. They also were innkeepers, shopkeepers, and held political office, sometimes all at the same time. Dr. Robert Bouldin was the only one who kept to one profession and even he was also a newspaper man, helping to edit Richard's paper while Richard was in the Union Army.

In politics Charles D. was an early adherent of Andrew Jackson. So were his sons, but when the Democratic party in Maryland split in the 1850's, sons William and Richard joined the American, or Know-nothing, Party. Both edited papers for that party. In 1857 William's Bel Air paper, The National American, had two mottoes: "The Union, The Constitution, and States' Rights" and "Americans only shall rule America." As the Civil War approached, the family split, as so many other Maryland families did. Charles D. and Richard went for the Union, and William sympathized with the South. All, however, backed the Constitutional-Union Party and then the Union Party that ruled Maryland until 1867. When the Union Party split back into Democrat and Republican the brothers found themselves on opposite sides, William as a Democrat and Richard as a Republican.




