DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This rectangular utilitarian structure is on the east side of South Main Street at #125, in the Town of Bel Air, Harford County, Maryland. Built of rock-faced cement blocks with plain cement block quoins at the corners, the building has a hipped roof covered with asphalt shingles. A wooden overhang covered with tarpaper and supported by seven wooden angle posts shades the south elevation. Two ventilators pierce the ends of the ridge, and an inside chimney with a plain cap rises in the west elevation just to the north of the entry. The structure is unevenly bayed and has a variety of windows. The majority of the windows are multi-pane steel framed with several panels in the middle that swing on an axis to open. Four of these windows in the south elevation are boarded up. The north two bays of the front (west) elevation are the service bays. The middle bay is occupied by a steel framed window. The entrance is between this window and a plate glass show window. The rear (east) elevation has a blocked entry. Since the lot slopes away to the east this door was served by a frame stoop.

The interior is divided into two spaces: to the southeast a showroom 30' x 30', the rest is open space occupied by the service bays and storage racks.

STATEMENT OF SIGNIFICANCE

This rock-faced concrete block building is a well-preserved example of the early 20th century utilitarian construction used for garages and filling stations in Bel Air, Harford, and Baltimore Counties, as well as around the nation. Several Bel Air buildings, smaller and less well cared-for, remain on the Pike between Main Street and the Tollgate Road. The material was also used for domestic construction. Several examples may be seen south along the Pike in Kingsville, Perry Hall, and Putty Hill. Apparently Bel Air regarded the material as too utilitarian for domestic use.

The land and a paint and hardware store and dwelling at the corner of Main Street and Churchville Road were part of the Bradford family's property. Governor Bradford's house was on the next north lot and was demolished in 1961 for a municipal parking lot. A store operated by . Herron occupied the property as early as 1842. The land was then owned by Otho Scott. The store was kept by Mr. Greenfield from 1867 until 1881 when he became a bookkeeper in the employ of Hanway and Rouse, who took over the store and sold hardware, machinery, lumber, and coal. The firm seems later to have been Hanway, Barnes, and McComas. This firm operated on into the 20th century. It is not certain that the storehouse on the lot during the pre-Civil War era was the same one on the lot when Albert Magness bought it in 1925. The 1878 map shows the structure as smaller than the 1904 insurance map has it. There is, however, no documentary evidence of a new storehouse being built. Probably it was expanded. Sometime before 1960 the store and dwelling were removed. During the time the Magness family owned the property they occupied the dwelling and ran a restaurant in the store. Magness built the present structure as a garage shortly after he bought the property for \$8,000 from J. Myrckle Wells in 1925 (193/379). Wells had purchased it from Lavinia Bradford and Ruskin B. Warren three months earlier (193/59). The garage may have been built in 1927 because the Magnesses mortgaged the property (204/442) to the Germantown Permanent Building Association in that year. In the midst of the Great Depression (1935) Magness defaulted on the the mortgage and the property was sold at auction. No buyers appeared and the Building Association bought it in. The property was not sold again until 1947 when it went to Henry E. Lieske and Paige K. Richardson. In November 1949 Mr. Lieske's share was removed from ownership by a sale to Thomas H. R. O'Neill who sold it back the same day to Richardson (336/319). Lieske and Richardson owned Cary's.


