DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two story, three bay house is at 903 Williams Street in the Town of Bel Air, Harford County, Maryland. It is sided in rolled asphalt and has a gable roof. The windows are 6/6. The front (west) porch has a hipped roof on square posts and a solid balustrade. The entrance is in the middle bay. The back (east) porch is in the south two bays of the east elevation. It has a hipped roof and is now enclosed. The back door is in the middle bay.

The house is unusual for having two bays on the narrow north elevation, in the first story both are doors, the west one sheltered under a shed-roofed unsupported hood. There are two chimneys - an inside end on the south and one in the middle of the roof ridge.

This plain house was built in 1887 by John R. and Annie E. Bedford on land they bought from E. Hall Richardson (59/510). The builder was Patrick Dunnigan. The house is utterly plain and perhaps more typical of the country than the village during that period.

The present owner, Joshua E. Fisher, Jr., bought it from Sally and Calvin Greene in 1960 (563/566). The original lot was larger.



