This cosy cottage, c. 1935, surrounds a much older two room tenant house, which belonged to Colonel Webster's estate "Ingleside". The big house was razed in 1978, so the interior two rooms of this house are all that remain of the estate. The varying gable roofs of the house and particularly the steep pitched front dormer with its round-headed window are quaint without being cloying.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small cottage is at 615 N. Hickory Avenue in the Town of Bel Air, Harford County, Maryland. It is a two story, four bay, L-shaped, shiplap-sided structure with various slate gable roofs. The front (west) elevation shows the north two bays with their own steep gable roof. The south two bays have a different gable roof broken in the middle by a steep gable dormer with a triangular vent and a round-headed 6/6 double-hung sash window. The first story of this section has the door (north) and a window (south). Shading the front door with its single pane over panel sidelights is a one bay gable roofed porch carried on square posts. The one and a half story ell is behind the south two bays; a single story kitchen addition is on the south elevation of the ell; its shed roof slopes down to the south. The back door is on the east elevation of the shed, sheltered by a shed roofed hood on wrought iron brackets. The rear elevation of the north two bays shows a very steep gable roof sloping down over an enclosed porch and having two shed-roofed dormers breaking the slope. An outside end chimney is on the north elevation. All the windows are 6/6.

The interior has a long living room across the front (west). Behind that (southeast) is the kitchen, in the middle is the dining room, and to the northeast is the enclosed porch which serves as a library. There are three bedrooms and two baths upstairs.

STATEMENT OF SIGNIFICANCE

This L-shaped cottage with various gable roofs and a steeply pitched front gable was constructed in the 1930's around a very small tenant house on Colonel Webster's estate "Ingleside". The present owners, Andrew and Mary Bristow, are mainstays of the Harford County Historical Society. Mary Bristow is a writer and local historian. According to her the house was only one room up and down well into the 20th century. In Colonel Webster's will, probated in 1893, the house was mentioned as "the small house in which Henry Osborn now lives". Around 1900 Howard Coale, a farmer for J. Edwin Webster, lived there.

The estate was devised to Ida W. Hunter (Mrs. J. Abell Hunter), Colonel Webster's daughter (will 11/315). In 1907 she sold it to her brother J. Edwin Webster for \$1500 (122/178). He mortgaged it in 1921 (175/301) and defaulted in 1932. It was sold at public auction (223/211). At the time the property was 73 acres. In 1935 Henry T. Crocker and Edwin H. W. Harlan bought 35 acres (237/266). In 1937 Adelaide D. Grant bought this house (244/367). It was either under her ownership or that of Crocker and Harlan that the house was enlarged to the present size.

In 1961 Anthony and Doris Lombardi bought it (577/276) and in 1964 the Bristows bought it (655/495).


