

SUMMARY

Erwin-Lauck House
3315 Rocks Chrome Hill Road
Forest Hill, Maryland 21050

Built by Thomas Erwin between 1879 and 1900, this 2-story clapboard house has retained evidence of a former modest elegance, in spite of being badly vandalized in the past 20 years. The small-scale center hall plan, beaded vertical board wainscot, and window and door trim with mitred pediments on the interior bespeak certain aspirations for this house that distinguish it from others of this type.

The present owner plans to restore the house.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Erwin-Lauch House

This 2-story frame clapboard house in badly-deteriorated condition, is located on the Southeast side of Rocks Chrome Hill Road, just West of the intersection with Rocks Rd. (Md. Rt. 24).

Facing Northeast - or North for the purposes of this description, this gable-roofed house is set into a bank on a stone foundation so the South side has a full ground story. The house is 3 bays wide and 2 bays deep with a 1-story shed-roofed addition on the East, measuring 34'10" (or 26' without the addition) by 18'5". With 2 interior end brick chimenys, the gable roof has a boxed cornice and gable returns. Most windows have lost their sash, although at least 2 first story windows have retained their 6/6 sash and at least 2 second story windows have retained their 2/2 sash; all have narrow beaded trim. The main entrance is in the center bay of the North side, with an additional entrance in the North side of the addition.

The interior has a center hall plan, with a staircase extending the full width of the hall. Most of the woodwork is missing now, although the eastern room has vertical beaded board panelling around the door and a cupboard in the chimney breast. The eastern room has a beaded vertical board wainscot around most of the room (including the chimney breast) and the windows, doors and niche South of the fireplace have trim with a mitered pediment. There are holes for stove flues in both chimney breasts.

The 2nd story has 3 bedrooms with plain wide trim, hewn floor joists, and circular sawn lath. The attic has straight sawn joists and sawn rafters butted together. The basement contains a fireplace of cut stone in the east wall and has hewn posts and at least some hewn joists.

STATEMENT OF SIGNIFICANCE

Although architectural evidence is ambiguous, historical records indicate that the Erwin-Lauck frame house was built between 1879 and 1900 by Thomas Erwin. In 1879 Erwin purchased a 35 acre lot of the 80 acre property that had belonged to Corbin Street at his death in 1874.¹ (This may be part of the tract "David's Hope", patented to David Tate in 1794.) He paid \$340 for this and twenty years later sold it for \$450 to John C. Ayers, who the next year sold back to Erwin the parcel "whereon Thomas Erwin now resided".² Two months later Thomas Erwin conveyed the 35 acres to Lenora A. Hazlett for \$550.³

Although the house is now in badly-deteriorated condition, remnants of a former modest elegance are still apparent. The trim with mitered pediments and beaded board wainscot in the East room, the beaded board panelling in the West room, the small-scale center hall plan, the gable returns on the exterior...all bespeak certain aspirations for the house that distinguish it from other late 19th century 3 bay by 2 bay gable-roofed clapboard houses.

The current owner intends to resuscitate the house.
