DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This L-shaped stone dwelling is located on Harmony Church Road just east of the Deer Creek. The house is two stories high and faces south.

Masonry in this house is very evenly laid, well cut stone. There are large, plain quoins and stone lintels.

The slate roof is gable flank. A corbeled chimney is located at each end, flush with the walls.

The main part of this house is five bays by two with the principal entrance being in the center bay. This doorway has a four light transom. The door itself is of wood, with eight moulded panels. There is a large iron box lock. A pedimented entrance porch with Roman doric columns shields the doorway. Windows are six lights over six. The windows on the upper story have louvered shutters.

This unit is built onto a high lighted basement. We were unable to view the cellar, however.

A stone addition on the northeast is also two stories high. This houses the dwelling's kitchen. The roof is perpendicular to the main unit. A corbeled brick chimney is located at the north end flush with the wall. There is no cellar under this section. A one story shed is attached to this unit. It abuts the main unit's center bay "back" door.

A white washed stone barn is located northeast of the main house. The lower level faces south. Two large wooden doors are on the northern facade.

STATEMENT OF SIGNIFICANCE

This farm is located on the tract, Hall's Rich Neck, which was patented in 1699 by John Hall. The stone house on this land is believed to have been built in 1844 by Elisha Cook. Cook apparently did quite well in this area and the small town that grew up along Deer Creek was known as Cooksville.

C. Milton Wright states in Our Harford Heritage that a tanbark mill and tannery was located at Cookville, near the site of an old woolen mill. Wright mentions that it was run by George P. Cook for several years after 1842, in connection with his country store. George, no doubt, worked with his father, Elisha, who died in 1853.

The old woolen mill mentioned above was also a Cook family enterprise. Samuel Mason relates that the property in Cooksville near Glenville "was bought by Elisha Cook in 1816, who immediately began building a dam and race which was to furnish power for the spinning and weaving mill. Here was spun and woven cloth produced from fleeces brought by farmers from the nearby farms. The mill continued in operation until about 1850, when not being able to compete with modern spinning mills, it was forced to shut down."

The house, itself, is a fine example of well cut stone. The house has been changed very little through the years. Mr. Weaver, the owner, is himself a stone mason of considerable note. He has constructed many handsome stone structures in Harford County. He is also known regionally for his paintings, many of which depict Harford County homes and outbuildings. An oil painting which hangs over his studio fireplace shows the artist's conception of how his spot along the Deer Creek looked when Cooksville was alive.

Weaver's Barn, surveyed by Jean Ewing in 1971, burned a few years ago. The Stone barn is in ruins. Mr. Weaver told me that it had a datestone of 1825 but this has been removed from what little remains of the structure.

Another barn, dating from the mid 1800's remains. This is located northeast of the house.

This old farm house is virtually unchanged except that fifty to eighty years ago the fireplaces were rebuilt to accommodate room heaters, kerosene.

The owner still farms - (pasturing beef cattle) ~~has~~ stone masonry, and dabbles in painting, his work having been shown at the Baltimore Museum of art on many occasions.

The setting of this simple house is strikingly beautiful, with a wide view west, north and east across Deer Creek.





