The village of Dublin is a typical cross roads service center which has changed little in appearance over the last 100 years. The Wiles-Daugherty House is a typical vernacular residence found in small communities like Dublin. It was constructed sometime between 1859 and 1873.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This residence is located on the west side of Whiteford Road (RD 136) in the village of Dublin. The structure faces south and is a two story gable end roof house, two bays wide by one bay deep--an I-house, with an entrance in the east bay of the south facade that is sheltered by a modern porch hood. There is a 1 1/2 story wing attached to the west end. At the west end of the main block is a large exterior brick chimney, which is of course partially built into the wing. The house has modern 1/1 windows, and modern asbestos shingle siding and an asphalt shingle roof. The interior was not accessible. It is not known whether this house is constructed of logs, or is simply a frame residence. The former could be possible because of the depth of the walls as observed at the window openings. Since the date of the house's construction has been narrowed by the title search, it would be exciting to determine if log residences were still being built in the late second or early third quarter of the 19th century, especially in a village setting.

STATEMENT OF SIGNIFICANCE

This house appears on the 1878 Martenet map of Harford County where it is identified as "Jno. Daugherty". It is not on the earlier 1858 atlas. The title search records a sale for 1 1/4 acres of land from Harry and Martha Stokes to Alfred Miles for the sum of \$1.00. In 1873 the Miles sold the land to John Daugherty, and the deed makes reference to "All the land now occupied by Friscilla Miles." The cost of the transaction was \$300.00, which would certainly indicate that a house had been constructed on the premises since 1859. Stylistically, this residence seems to be a typical vernacular construction, although this conclusion is admittedly based on an exterior examination only. There are no traces of any ornament, and the basic side hall plan resembles other rural dwellings of the period.

Apparently the time between 1858 and 1878 did not see a tremendous amount of growth in the cross roads village of Dublin. The largest number of dwellings was concentrated on the north side of Dublin Road east of the intersection with Whiteford Road--these structures are noted on the earlier 1858 map. The village was probably a typical 19th century service center for the outlying farms and occasional travelers. By 1878, it boasted a church, hotel and store. In 1981, it is still serving the same essential function, since there are no concentrated residential developments close to the cross roads. The hotel is gone, but there is still a store that sells hardware as well as a grocery store and a Methodist Church, and an elementary school.
