DESCRIPTION

The Heaps Farmstead consists of a 2-story frame I-house and wooden barn and small shed, all of which date to the late 19th or early 20th century. The Farmstead occupies a gentle hillslope located at the headwaters of Jacks Hole (Creek) and situated several hundred feet north of Pylesville Road (State Route 165). A dirt road passes by the barn and shed, separating them from the south-southeastward facing farmhouse.

The three-bay farmhouse rests on a coursed sandstone rubble foundation and is sheathed in 3 inch wide clapboard siding with cornerboards. The slate-covered medium pitch gable roof features a cross-gable design, boxed cornice, and freezeboard. Single brick chimneys are located off-center on the front roof peak and on the rear gable end.

The paired 1/1 and 1/2 light sash windows are embellished on their caps with curvilinear moldings, as are the door frames. Pintels on the windows denote the former use of shutters. The main, centrally located doorway is enhanced by a stained glass transom and sidelights and by its five-panel molded door.

Spanning most of the front (south) elevation is a deteriorating wooden, hip roofed porch with beaded board ceiling and flooring, turned posts, and curvilinear brackets. Two smaller porch enclosures are on the west elevation and east elevations.

Approximately 30 yards east of the dwelling is a large post-and-beam style bank barn which, from a pre-1920 historic photograph, appears to be contemporaneous with the farmhouse. Except in a few places where concrete blocks have been installed, the foundation remains as coursed sandstone rubble; slate covers the gable roof and shed addition.

About 20 yards north of the barn is a small rectangular shed-like structure resting on wooden post supports. Vertical planking provides the framing and wall surfaces, and the medium pitch gable roof is slate covered. Windows consist of square openings covered with wire mesh.

The three buildings appear to be generally unmodified except for the removal of the shutters on the farmhouse and the disappearance of the southern and eastern barn appendages (as seen in the pre-1920 photograph).

SIGNIFICANCE


The Heaps house is a typical example of late 19th/early 20th century, rural vernacular Victorian architecture. The Victorian elements, conspicuously limited to curvilinear designs on the door and window frames and porch brackets, contrast the otherwise stark simplicity and functionality of design characteristic of late 19th century farmstead architecture.

The dwelling is nearly identical in design to another Heaps family farmhouse located almost directly opposite it on the south side of Pylesville Road. However, the building under study has retained more of its integrity and is therefore considered a better example of its architectural theme.


From the available secondary literature, the history of the property remains sketchy. The Aegis Historical and Industrial Edition (Mitchell 1920:35), however, includes an early photograph of the farmstead which I.W. Heaps reportedly purchased from W.F. Wilson in 1897 and which (in 1920) was known as the Genoa Stock Farm. Because the present owner of the property was unavailable, no additional information or photographs were obtained.
