The Keech-Rosenberg House, 42 W. Gordon, faces south in a block of tree-shaded houses built in Richardson's Addition in the 1930s and 1940s. A 2 story, 3 bay white clapboard house built in 1934 or 1935, it is the only one to have a definite style; it is a Dutch colonial.

Building began west of Main St. in Richardson's Addition in the 1880s; it and the Hayes Addition begun at the same time are the oldest extensions of the town. It is a mix of styles from Victorian to brick rancher, and a mix of classes as well, with working-man's housing along the north and south edges and middle class homes through the center. Indian Hill is the part of the addition reserved around the Richardson home place of the same name which faced Main Street. The heirs subdivided it in 1931 when they sold the house. This stylish Dutch colonial is the only one of its kind in the neighborhood, although there are two in Ingleside [HA-1832 and HA-1841] built in the early 1920s. Bel Air residents did not build in the revival styles much in the interwar years, preferring instead the bungalow and the four-square. The house was built for J. Harold Keech in 1934-1935.

The Keech-Rosenberg House, 42 W. Gordon, faces south in a block of tree-shaded houses built in the 1930s and 1940s. A 2 story, 3 bay white clapboard house built in 1934 or 1935, it is the only one to have a definite style; it is one of 3 Dutch colonials built in Bel Air between the World Wars. The other 2 are in Ingleside [HA-1832 and HA-1841].

Its full width shed dormers front and rear, its paired 6/1 double-hung sash windows flanked by black shutters, and its sun room (east ) with a crowning balustrade make it typical of this comfortable style. Its gabled portico has a slight return and is carried on 2 round columns. There is a single story gabled addition in the center bay of the rear (north) elevation. The interior was not accessible.

Aaron Rosenberg, the manager of the Hub, a furniture store on Main Street, bought the property in 1948. His widow, Grace Ruth Rosenberg, is now in a nursing home in Baltimore, and the house is vacant. As a result the interior was not available to the surveyor. The only obvious alteration is a gabled single-story addition in the middle bay of the rear (north) elevation, done by the Rosenbergs in the 1960s.


