The Putnam House, 112 W. Gordon, faces south on a narrow hedge-bordered lot in Richardson's Addition. Built between 1915 and 1930, it is a gable-front, 2 story, 2 bay house in asphalt siding, currently painted blue. This block of W. Gordon contains a variety of styles: the Wren Box, a stone cottage on the corner facing Williams street, an elegant 4-square, and two small working-man's cottages similar to those in the 100 block of W. Broadway.

Building began west of Main St. in Richardson's Addition in the 1880s; it and the Hayes Addition begun at the same time are the oldest extensions of the town. It is a mix of styles from Victorian to brick rancher, and a mix of classes as well, with working-man's housing along the north and south edges and middle class homes through the center. The Putnam House is a 2 bay front-gable house of a kind built all over Bel Air from the 1880s to after World War I. It was built sometime between the time the Putnams bought the lot in 1915 and 1930, as it appears on the Sanborn insurance map of that year.

The Putnam House, 112 W. Gordon, faces south on a narrow hedge-bordered lot in Richardson's Addition. Gordon contains a variety of styles: the Wren Box, a stone cottage on the corner facing Williams street, an elegant 4-square, and two small working-man's cottages similar to those in the 100 block of W. Broadway.

The hipped front porch is carried on 3 round posts; there is a rose trellis on the east side. Windows are 3/1 double-hung sash, flanked by black plastic shutters in front, except for the one in the gable. Fenestration of the 2 bay east elevation is regular, except for the small window in the middle of the second story. It probably lights the bathroom. The west elevation, however, has irregular window spacing. The front (south) bay downstairs is blank. It probably has the staircase. The rear bay has double windows, possibly the kitchen. An enclosed shed porch is in back.

The interior was not accessible.

It was built sometime between the time the Putnams bought the lot in 1915 and 1930, as it appears on the Sanborn insurance map of that year.

Carrie Putnam died and Mr. Putnam remarried. He died in 1946 and left the property to his widow, Emma, for her life or until she remarried, with the remainder to his sons William and Walter. In 1954 William and Walter conveyed their interest to Emma and Herbert J. and Tamsye Miller. The Millers died before Emma, who got sole ownership. She died in 1977, and the property was sold to the present owners, Denis and Barbara Canavan.


