The Stinchcomb House, 28 Hickory Ave., faces south on a rise over the street across from the Bel Air Town Hall. Built around 1932, the house is a 1 1/2 story cottage gable roofed stone T-shaped cottage. It is between a large bungalow and a clapboard cottage with fieldstone accents.

This block of Hickory was vacant on the 1930 Sandborn Insurance Map, except for a chicken farm on the south corner. There was nothing but farm land across the street where the Bel Air Town Hall and the Public Library now stand. Contractor Harry Orsburn bought a \$2000 defaulted mortgage in 1931 and subdivided it. It seems reasonable to suppose that he built the houses, two of which -- HA-1808 and this one -- were in a style new to Bel Air, a cozy cottage. The house may have been built in 1932 as the title suggests, since HA-1808, which, although clapboard, resembles it, was built in 1935. This stone cottage is unique in the Bel Air survey, more horizontal than the styles of the 1920s and built of stone, which is unusual in town in any style.

The Stinchcomb House, 28 Hickory Ave., faces south on a rise over the street across from the Bel Air Town Hall. Built around 1932, the house represents a transition in Bel Air architecture. As tastes began to change in the 1930s, the blocky styles of the 1920s -- the four-square and the bungalow -- gave way in some areas to a 1 1/2 story cottage style more horizontal and cozy. The house is unusual in its fieldstone construction, which is not often found in town.

The 3 bay house has a gable-roofed front (east) block with an equally wide gabled section to the rear (west), its roof at right angles to the front. Twin double windowed gable-roofed dormers adorn both sides of the rear gable (south and north). There are replacement windows throughout. The rapid movement of the stone facade is thrust down by a narrow continuation of the south gable which widens half way down into a small wall at right angles to the facade; this defines the plane of the facade as well as the front patio and is stopped by the gable over the round-arched entrance (in the south bay). The eye is forced down again and to the side and then back up as the motion flows up the chimney which rises between the multipaned window ending near the roof line and a pair of casements. A side entrance on the south is topped by a small shed roof. Single double-hung sash windows occur on the other 3 elevations.

The interior has been much altered by the conversion of the house to medical offices. Original elements include the massive fieldstone fire-place (no mantel) with a bench under the window on the south in the east wall of the former living room and the open string straight-run staircase with carved brackets and a balustrade of slender, tapered balusters along the south wall. A slender turned newel ends in a handrail scroll. The rest of the level is now examining rooms. The second story has one large room (south) and a kitchen flanking a large hall, all of which are recent.

Kenneth Smick, who owned the property from 1932 to 1943, had a store in Edgewood in 1953.

Kenneth Stinchcomb, owner from 1943 to 1965, owned Kroh's Cleaners in Bel Air.

Linwood Beshore, owner from 1965 to 1967, owned a furniture store on Main Street. He and his wife were killed in an automobile accident.

Robert Lawrence, the present owner, is a chiropractor. During his ownership the ground floor was altered into waiting room and examining rooms. The second floor room and kitchen also date to his ownership.


