The Harlan House, 330 E. Broadway, faces south set back from the tree lined street on a narrow lot in Ingleside. Begun in December 1924, it is a 3 bay beige bungalow with a broad 3 window shed dormer in front (and probably in the back), similar to the other bungalows built in Ingleside during the 1920s.

The early 1920s saw three new additions to the Town of Bel Air: Fulford Park (1922), Ingleside (1923), and Kenmore (1924). In each case the lots were sold at auction. Ingleside was subdivided by J. Edwin Webster and named for his home to the north. Begun in December 1924, the Harlan House is an elegant clapboard bungalow similar to others of that style being built in Ingleside and elsewhere around Town in the 1920s. The house was built for Edwin W. H. Harlan, son of Judge William Henry Harlan (1850-1942). His mother, Bessie Webster Harlan, was the daughter of Col. Edwin H. Webster, Judge Harlan's partner and father of J. Edwin Webster, the man who subdivided Ingleside. Webster was thus his uncle.

The Harlan House, 330 E. Broadway, faces south set back from the tree lined street. Begun in December 1924, it is a 3 bay beige bungalow with a broad 3 window shed dormer in front (and probably in the back), similar to the other bungalows built in Ingleside during the 1920s.

An extension of the roof forms the front porch, which is carried on 4 round wooden posts. Windows are 1/1 double-hung sash. Those in the first floor front are flanked by long brown shutters. Entry is in the middle bay of the facade. An entrance with a shed-roofed stoop is in the middle of the east elevation. It probably leads to the upstairs apartment. The interior was not accessible.


