The Wilkinson-Famous House, 338 E. Broadway, faces south on a corner lot in Ingleside. Built between 1923 and 1931, it is a 3 bay, 2 story clapboard (now aluminum-sided) house with a slate gable roof, an exterior brick chimney along the east elevation, and a shed-roofed front porch carried on stock turned posts linked by a stock turned post balustrade of recent origin. This is one of Bel Air's favorite vernacular styles.

The early 1920s saw three new additions to the Town of Bel Air: Fulford Park (1922), Ingleside (1923), and Kenmore (1924). In each case the lots were sold at auction. Ingleside was subdivided by J. Edwin Webster and named for his home to the north. The Wilkinson-Famous House was built in the popular three bay gable-roofed vernacular style, by Mary Wilkinson, probably shortly after she bought the lot in 1923. It is one of the most altered houses on the current survey, but houses like it were built all over Town both before and after World War I. In about 70 years has gone from being a simple vernacular house to one with a good deal of sophisticated charm.

The Wilkinson-Famous House, 338 E. Broadway, faces south on a corner lot. Built between 1923 and 1931, it is a 3 bay, 2 story clapboard (now aluminum-sided) house with a slate gable roof, an exterior brick chimney along the east elevation, and a shed-roofed front porch carried on stock turned posts linked by a stock turned post balustrade of recent origin. This is one of Bel Air's favorite vernacular styles.

A shed-roofed sun room on the east elevation was originally a small open porch. A shed-roofed addition on the west bay of the rear (north) elevation leads to a deck to the east. Windows are 6/6 double-hung sash and are flanked by black plastic shutters. A Victorian door is in the west bay of the facade. It has an oval beveled and etched central glass portion and is a reproduction. A side entrance covered by a shed stoop is in the middle of the west elevation.

Virtually the whole interior has been changed by one owner or another. Entry is into a broad side hall. The open string dog-leg staircase with carved brackets, round newel and round tapered balusters rises along the west wall. To the right (east) is the living room, which has a fireplace with a marble mantel in the east wall. To the north is the dining room. The dado is recent. The sun room to the east has a full bath to the north. To the rear of the hall is the kitchen, which leads to a family dining room in the addition. Upstairs are 3 bedrooms and 1 1/2 baths. The attic and basement are finished. The foundation is poured concrete.

Alterations include adding a wall to the east of the entry to form a hall, all woodwork in the house, the mantel and dining room dado, renovating the kitchen, enclosing the side porch and adding a bath room to it, adding the family room and deck, and adding a half bath to the northwest bedroom. The front porch is also an addition. Apparently the original was much smaller. The result is a house with a colonial flavor inside and out.

Mrs. Wilkinson's heirs, Mamie Wilkinson and John N. Wilkinson, sold the house in 1931 to Charles H. Reed, a Bel Air lawyer and agent for the Royal Fire Insurance Co. John Wilkinson also owned an insurance company and has been mayor of Bel Air. The Reeds sold the property to Curtis L. Famous, of Famous & Spang Insurance Co., of Aberdeen, in 1931. Robert and Leonora Ordakowski bought the house after the death of Mrs. Famous in 1976. They paid \$52,000.

All the interior alterations to floor plan and woodwork except for the renovation of the kitchen and the rear addition were done by the Ordakowskis, as was the enclosure of the side porch.

In 1985 pediatrician Steven W. Dannenfelser and his wife Mary bought the house for \$115,000. They re-did the kitchen, put the addition on the rear of the house, and sold it five years later to the present owners, James and Jennifer Caulfield, for \$170,000.


