The Carroll House, 405 E. Broadway, is one of the simplest bungalows in Ingleside. Built in 1929-1930, it faces north on a deep, tree-shaded lot. The porch is formed by the extension of the roof carried on stock turned posts linked by a square post balustrade. The wrap-around deck on the east and south elevations and the shed-roofed dormer are the only exterior projections. Five rooms plus bath down and 2 bedrooms and a half bath up make this a roomy, if compact, house.

The early 1920s saw three new additions to the Town of Bel Air: Fulford Park (1922), Ingleside (1923), and Kenmore (1924). In each case the lots were sold at auction. Ingleside was subdivided by J. Edwin Webster and named for his home to the north. This simple working-man's house, built in the late 1920s and changed many times since, is an example of the transition in Bel Air working-man's housing from shot-gun style to the new bungalow style.



The Carroll House, 405 E. Broadway, is one of the simplest bungalows in Ingleside. Built in 1929-1930, it faces north on a deep, tree-shaded lot. The porch is formed by the extension of the roof carried on stock turned posts linked by a square post balustrade. The wrap-around deck on the east and south elevations and the shed-roofed dormer are the only exterior projections. Five rooms plus bath down and 2 bedrooms and a half bath up make this a roomy, if compact, house.

Paired double hung 3/1 sash windows and a pair of recent french windows in the east wall of the dining room provide light, as do the 3/1 double-hung sash windows in the dormer. Entry is in the center of the 3 bays of the front elevation. It leads directly to the living room which has a closed-string staircase with square newel and balusters along the east wall. The low white brick fireplace in the south wall of the living room and a narrow cornice over the door leading to the sitting room (a former bedroom) date to the 1950s. South of the living room-sitting room are the dining room (east) and a small hall with a bath off it to the west and a bedroom to the south. The kitchen is to the south. Upstairs are the 2 bedrooms and a half bath. With the exception of the corniced lintel to the sitting room door, the woodwork throughout the house is plain.

The early 1920s saw three new additions to the Town of Bel Air: Fulford Park (1922), Ingleside (1923), and Kenmore (1924). In each case the lots were sold at auction. Ingleside was subdivided by J. Edwin Webster and named for his home to the north.

This simple working-man's house, built in the late 1920s and changed many times since, is an example of the transition in Bel Air working-man's housing from shot-gun style to the new bungalow style.

The current owner believes the house to have been the "bunkhouse" for the Ingleside estate, but since the property was conveyed in 1923 (181/493) with the restrictions as to price and African-American residence, it seems most likely that the lot was then unoccupied. One wonders if the little house actually cost \$3000, as the restrictions required, when it was built.

It is not possible to date many of the changes to the house. By its style, the fireplace dates to the 1950s, as does the narrow pediment over the door between the sitting room, formerly a bedroom, and the living room. Perhaps the staircase was moved at the same time. The deck and the French windows in the dining room which lead to it were built by the current owners.

Edward Hogarth, the 1958-63 owner, was a landscape gardener.


