The Bartholomaei House, 325 S. Main St., faces west on a portion of Main St. that is rapidly becoming commercial. It houses doctors' offices. Built in Fulford Park between 1922 and 1930, it is a 3 bay, 2 story clapboard four-square. Its hipped roof is, oddly enough, without dormers. Now painted blue, its opening surrounds are in contrasting white as are the 4 square posts that support its hipped-roof porch, the northern 2 bays of which have arched trellises. White downspouts at each edge give the impression of outlining the planes of the house. The vermilion entry door, in the south bay of the facade, has 4 panels topped by 4 small panes of glass. The house is an utterly contained box and unlike any other on the survey.

The early 1920s saw three new additions to the Town of Bel Air: Fulford Park (1922), Ingleside (1923), and Kenmore (1924). In each case the lots were sold at auction. Fulford Park was subdivided by Oliver T. Wallace of Wilmington, North Carolina. The local agent was W. M. Nicholls. It was named for the Fulford family whose land it once was. Probably built in the early 1920s, the Bartholomaei House is a tidy four-square of a kind uncommon in Town, because no dormers break its hipped roof. The first owner, Mrs. Annie E. Bartholomaei, had been Mrs. Annie Bauer who ran a bakery at 18 S. Main Street [HA-1448] after 1904.

A stone exterior chimney rises along the north bay, west of center. Windows are 1/1 double-hung sash and are disposed regularly front and rear, the rear elevation having small windows in the middle. The south elevation is irregular. It has 2 small windows in the west bay, the second story one diagonally above the first story one. They probably light the staircase. The east 2 bays follow the east elevation pattern. The elevation is further broken by a side entry with a gable stoop on diagonal wood braces between the smallest window and the window in the middle bay, just west of center.

The interior was not accessible.

Bartholomaei, had been Mrs. Annie Bauer who ran a bakery at 18 S. Main Street [HA-1448] after 1904.

According to The Aegis of 12 January 1917, Mrs. Bauer "surprised her friends" by marrying Albert S. Bartholomaei in a quiet ceremony in New York City. Bartholomaei was a native of Baltimore, and the couple moved to Texas where Bartholomaei represented the Maryland Casualty Co. Mrs. Bartholomaei died in 1950 and her heirs sold it to two of the heirs, Mary D. Bauer and Mary Ann Bauer. It stayed in the extended Bauer family until 1978. It is currently owned by Shelly Fingerhood, MD, and his wife, Anita Hirsch, MD. It serves as doctors offices.


