The Wells House, 438 S. Main St., faces east on a corner lot in Kenmore in a block that is rapidly going commercial. It is in the process of being renovated for commercial use. It is a 3 bay clapboard bungalow painted blue with white trim and darker blue door and paneled shutters that look original. Front and rear dormers have shed roofs. Windows are 1/1 double-hung sash replacements, doubled except in the north bay of the rear dormer. A large, hip-roofed single story addition with long rectangular windows and wooden access ramp and stairs to the second story have been added in the renovation.

The early 1920s saw three new additions to the Town of Bel Air: Fulford Park (1922), Ingleside (1923), and Kenmore (1924). In each case the lots were sold at auction. Kenmore was named for Harry Hanway's Kenmore dairy farm which was the land being developed. The Wells House, built in 1925 for auto dealer J. Myrckle Wells, is a clapboard bungalow typical of the kind being built around Town in the mid-1920s.

The house is currently being renovated for commercial use. The large addition to the rear and the access ramp and outside stairs spoil the effect of the bungalow somewhat.


