This lighthouse is one of three remaining battery lights of this design in the Chesapeake Bay where the light is located on top of the light keeper's house. One of these has deteriorated to the point of becoming a ruin. Our reference material indicates that Fishing Battery Light was demolished. The fact that it still exists means that there are 25 remaining lighthouses in the Bay rather than the 24 previously studied. Our reference also dates this lighthouse to 1853 which appears to be likely based on its architectural design. This would indicate that it is one of the earlier lights in the Bay. Fishing Battery Light is eligible for the National Register under Criteria A and C because it is part of a thematic group of the few remaining historic lighthouses in the Chesapeake Bay and for its unique architectural design in Maryland.

Principal importance of this facility is as an historical landmark dating back to the era of the Civil War. "Fishing Battery Light" has been a well known mark to sailors of the upper Chesapeake Bay since that time. This was also the site of an early shad fish hatchery during the early 1900s.


