DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Rock Run Bridge Toll House, located on Stafford Road near Rock Run, is a one-storey, two bay wide, two bay deep clapboard dwelling dating from the early 19th century. This structure, built into a natural slope of land, has a high fieldstone foundation. A brick chimney is centrally located in the wood-shingled gable roof. Beaded rake boards, plain corner boards, and a box cornice further articulate the structure.

The main two-bay (east) facade is defined by a doorway in the northern bay flanked to the south by a 6/6 sashed and louvered shuttered window. The dutch, vertical boarded door has heavy strap hinges. A shed-roofed open porch spans this front facade extending on an additional bay to the north was a 6/6 sashed window. This covered area allowed the tollman to view the canal traffic without physically leaving his station.

The south gable facade carries two 6/6 sashed and louver shuttered windows on the first storey and two nine-light, fixed-sashed windows at attic level.

In the southern bay of the west facade entrances are located at the exposed basement level and the first storey. A shed-roof hood with simple brackets shelters the first storey entrance. This doorway has been blocked off and is inaccessible from ground level.

The structure is built next to the ditch of the Susquehanna and Tidewater Canal and a stone causeway leading up to the bridge is on the southeast side of the structure.

Five very worn bridge piers are all that remain of the covered bridge that once spanned the River at this site. The abuttment is made of fitted granite blocks, quite similar to the construction of the Canal locks. The causeway next to the Canal crossed the ditch at the tollhouse and led to the abuttment.

STATEMENT OF SIGNIFICANCE

The following information was collected by Paul Penrod in 1976.

"The State Legislature of Maryland in 1815 authorized the construction of turnpike from Baltimore to Rock Run, passing through Bel Air. In 1808, the Rock Run Bridge and Banking Company was empowered to build the bridge which was begun in 1813 and completed in 1818 as was the tollhouse.

It was the first bridge in Maryland to span the Susquehanna River and it eventually replaced the ferry at Lapidum as the most used route across the water. The covered bridge, though often used, was constantly beset by disaster. A fire in 1823 immobilized the span until 1828. In 1854, a herd of cattle collapsed a segment of the bridge. Floods and icepacks in 1847 and in 1856 finally destroyed the bridge which once served as an important link between Philadelphia, Baltimore and Washington prior to the railroads."

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The tollhouse, which has been restored, faces the southeast. It is a one-story bevelled frame structure with a high stone foundation. The building is two bays by two, with 6 X 6 windows and nine-pane attic windows. One door is on the southeast facade, where the crossing fares were exacted, while the other is on the northeast side. A cellar door is located on the western wall, where the foundation is quite high. The roof is gable-flank, with wood shingles and underneath the eaves are original box cornices. A single brick chimney, also original, is located on the center of the roof. A four-bay porch is built along the southeastern wall, with a shed roof covering it as the board-and-batten extension. The structure is built right next to the ditch of the Susquehanna and Tidewater Canal and a stone causeway leading up to the bridge is on the southeast side of the structure.

Five very worn bridge piers are all that remain of the covered bridge that once spanned the river at this site. The abutment is made of fitted granite blocks, quite similar to the construction of the canal locks. The causeway next to the canal crossed the ditch at the tollhouse and led to the abutment.


