DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a one story frame church, three bays long with rubble stone foundations. Its gable front roof is covered with asphalt shingles. The roof has wide eaves. There is no steeple. A new, one story portico, on the west, faces the road and appears to have the original doors: double hung doors having eight moulded panels each. Above the portico near the point of the original church's roof is the semi circular date mark: HOSANNA A.M.E. CHURCH A.D. 1880.

A 1961 cinderblock addition called the "Parish House Annex" joins the church to the 1949 Parish House.


