
DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

This frame 2 1/2 story house, 5 bays x 2 faces south, the ridgepole running e-w.

Three peaked dormers are in each side of the wood roof of the main house windows here are 6 lights over 6.

There is a wing at the east end of the house, 1 story, 3 bays long - one large room ~~the~~ with windows in the end wall only in the gable, small, 4 over 4, this roof is slate. A huge cooking ~~stove~~ fireplace is in the east wall; small stairs circling around it to the attic. The wing is stone-stucco. This is the original house. The main house is on a well lighted stone

basement. Two chimneys at either end rise from 8 fire places (upstairs and down stairs).

He farmed this land for 50 years and entered into the milling businesses of the area including the paper mill, ~~first~~ furnace ~~at~~ at Stafford at Hopkins Branch on the river and

The present owner - Philadelphia Electric Co., holds ^{much of} the watershed of the Conowingo Dam, and is a reluctant landlord.

Despite the interest of the occupants this company indifference is resented and the house suffers!
