This large frame two-story house faces east, the ridgepole runs north-south, chimneys at either end. ^{5 bays x 2} A wing ~~4 bays x 2~~ runs west along the south wall. A smaller addition, 1 story, runs north, with a third chimney in the north wall.

Porch on the east, 1 story, over front door and a window on each side. Porch on south side, 1 story, across 4 windows. A large gable is in the east roof, center. Eaves are wide under the slate roof.

Setting - fine grove of maple & oak trees on wide hill top with barn and fields south and southwest below the house. Ample shrubbery.
