DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Three-part frame house running east-west, the two smaller parts to the west each 2 bays x 1, the ridge lines, separately, run east-west. The western part is 1½ stories, the central 2 stories. The east end of the house, 2½ stories, has a hip roof crowned by a square "captain's walk". Windows on the first floor are lap - 6/9 - on the south side of the house, and one opened out onto a terrace. A one story porch is on the east end of the house.

Space in the roof (for a chimney?) in the central section, east end, is filled with a skylight. Two chimneys remain.
