Land records reveal that the house was owned by the Husband Family and the initials on the datestone - "H.H. - M.H." - no doubt, refers to members of that family responsible for the dwelling's construction.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This huge, stone mansion is set back off Harmony Church Road. Its principal entrance is on the north facade.

The house consists of three main units, the latest having been built in the latter half of the nineteenth century by Dr. Hugh Jewett. The oldest unit bears a datestone of 1770 and the initials "HH - MH."

The largest unit, on the east end, is almost a cruciform shape, though never intended for such a somber use as religious service. The entire first floor of this coursed stone unit is a high-ceilinged, very grand ballroom, complete with parquet floors. This unit is two and one half stories high and the second floor is of frame construction with siding arranged in an imbricated pattern. The much dormered roof (I counted seven) has wood shingles. A tall, ornately corbeled, brick chimney rises from both the north and south sides of this roof. There are porches and balconies. The upper windows have wood, lattice work while the windows on the second elevation have louvered shutters. Windows on the south facade's first elevation are fitted with clear leaded glass in a lattice pattern, while the three windows on the east facade, which is bowed, are single pane sash, modern replacements.

The next unit, the oldest, has been altered to blend with the circa 1880 additions and it is very hard to imagine it as a product of the 1770's. This three bay unit is also two and one half stories high, though much lower in height than the unit previously described. This section has a slate, gable flank roof with one dormer on the north and two on the south. The dormers clearly represent a victorian embellishment. The 2/2 window sashes are rounded on the upper sash and the sides of the dormers look like reversed parentheses.

The north facade of this unit is presently used as the main entrance. The door and center window have been altered in size and shape. The western most window is the most unchanged. A semi-elliptical, brick arch is above this window and the center window. The datestone, mentioned earlier, is directly above the arch of the western window.

The south facade's windows and doors have been drastically altered to attempt a victorian flavor. A window and door have been re-worked into French doors - double hung, casement windows from ceiling to floor. A one tier porch runs the length of the south facade. It has bracketed columns. Windows on the second elevation have been changed to match those of the first addition.

STATEMENT OF SIGNIFICANCE

The property on which this stone mansion stands consists of acreage from the tracts Bachelor's Good Luck, Green Spring Forest and Hendley's Enlargement. Bachelor's Good Luck, which comprises most of this farm's acreage, was patented in 1703 by Enoch Spinks. The original tract consisted of 1,000 acres.

Remembered most commonly as the old Jewett Mansion, this family did, in fact, own the property over one hundred years. The estate was known as Lansdowne.

One of the most prominent inhabitants of this house was Hugh J. Jewett who was born at Lansdowne on July 1, 1817. He was the son of John and Susannah Judge Jewett. An attorney, Mr. Jewett spent the greater part of his life near Zanesville, Ohio. He served in the Legislature of Ohio from 1868-69 and in the U.S. House of Representatives from 1873-74. He became president of Central Ohio Railroad in 1857 and later president of the Erie Railroad in 1874. In 1884, he returned to Harford County, to live at Lansdowne. He is responsible for the restortation of the Deer Creek Friends Meeting House in 1888.

Susannah Judge Jewett, mother of Hugh, is described by Walter Preston as "a women of strong mind and a powerful minister" in his History of Harford County. She preached at the Deer Creek Friends Meeting House and served as Clerk of the Baltimore Yearly Meeting of Women Friends for many years.

The gardens surrounding this house show remnants a grand period of its history. Pin oaks line the back drive and some Japanese Iris, though scarce now, still survive. A maze was once located east of the house.

This unit is divided into two rooms and a side through hall. Originally there were two diagonal fireplaces using a chimney which is located on the west inside end of the corniced roof. The north fireplace has been closed but the south, parlor fireplace is still in use. The original mantle has been replaced by a beautiful, hand carved mantle, circa 1870. The dark wood has been carved into fruit and vegetables. The cellar under this unit is buttressed on the north. High semi-elliptical, stone arches serve as fireplace supports.

The third unit, also of coursed, rubble stone, is three bays long, one and one half stories high. This unit also has a slate roof with three dormers on each side. The dormers are heavily pedimented. The windows on the first elevation have semi-elliptical brick arches and louvered shutters. A door on the west facade leads to a glass enclosed porch that appears to be a fairly modern addition.

Semi-elliptical brick arches are above basement windows in both of the 1870's additions. The oldest unit has stone, semi-elliptical arches over its basement windows.

A brick and stone wall forms a small court yard west of the house. A small brick structure forms one corner (NW) of this wall.

There is also a large barn and a tenant house on this property.
