This large stone house is situated at the end of Deth's Ford Road in Darlington near what was once known as the Deer Creek's Dead or Death's Ford crossing of that waterway. The house situated on portions of the tracts, Neighborhood, Green Spring Forest and Batchelor's Good Luck.

The main unit of this house bears a datestone of 1807 although the rear unit of the house is suspected to be much older. This can not be ascertained by either the Federal Tax List of 1798 or the 1814 Maryland Tax List. The 1782 will of William Coale mentions his dwelling house on the property in question and specifies that his "daughters Sarah and Ann shall possess the two back rooms of my dwelling house and one half of the garden to themselves with the liberty of the kitchen to cook in..."

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is situated at the end of Deth's Ford Road on the Deer Creek. The house faces south.

The main unit of this house is five bays by two and two stories high. It is constructed of random ashlar stone and has large plain quoins. This unit has a gable flank, slate covered roof with a box cornice. A stone chimney is located at each gable end, flush with the wall. This unit has a lighted basement. Windows in the basement are six light casement windows.

The principle entrance of this unit is in the center bay on the south facade. The entrance has moulded paneling and architrave trim. The pegged, moulded panel door has a four light transom overhead. A one story entrance porch here has a gable roof with an arched ceiling. Windows in this unit are six lights over six and are pegged. Each window has louvered shutters. A flat stone arch is over each window on both the first and second elevation. The center voussoir is keystone shaped.

On the west facade there are no windows on either the first or second elevation. Two six light casement windows are located at the attic level. A round datestone near the peak of the roof is encircled by brick headers and wedge-shaped voussoirs. The datestone bears the inscription: "C, J (or I) and R, 1807."

Three bays of the north facade are visible. Two windows and a door correspond with those found on the south facade. A modern shed roof dormer has been added to the north side of the roof.

A portion of the roof extends to cover a one bay protrusion on the eastern part of the unit. This lines up with the south facade of the eastern unit.

One window is located on the east facade. A stone and frame unit covers the other bay of this facade.

The eastern stone and frame unit is one and one half stories high and has a gable flank, slate covered roof with a box cornice. One gabled dormer is located on the southern slope of the roof while two dormers - a gabled dormer and a shed roof dormer - are located on the northern slope. The gabled dormers are each six lights over six while the shed roofed dormer is a four light casement window. A stone chimney is flush with the east wall.

The south and half of the east facades are random ashlar stone. Windows are six lights over six on the south facade and have probably been widened and updated. A wooden stairway is attached to the east facade and leads to an entrance in the frame part of this unit. The frame portion of this unit is built onto high rubblestone foundations. The frame section serves as an enclosed porch with three very closely spaced windows on the south facade.

A two story ashlar stone unit of two bays is located on the north of the main unit. This unit has a gable flank, slate covered roof, whose ridge line runs North-

STATEMENT OF SIGNIFICANCE

This large stone house is situated at the end of Deth's Ford Road in Darlington near what was once known as the Deer Creek's Dead or Death's Ford crossing of that waterway. The house situated on portions of the tracts, Neighborhood, Green Spring Forest and Batchelor's Good Luck.

The main unit of this house bears a datestone of 1807 although the rear unit of the house is suspected to be much older. This can not be ascertained by either the Federal Tax List of 1798 or the 1814 Maryland Tax List. The 1782 will of William Coale mentions his dwelling house on the property in question and specifies that his "daughters Sarah and Ann shall possess the two back rooms of my dwelling house and one half of the garden to themselves with the liberty of the kitchen to cook in..."

The Jennings and Herrick Map of 1858 does not show the house near the Dead Ford but it is known that James C. Doddrell and his family lived there during that time. W. Stump Forward, in his 1880 Aegis report on "Homes on Deer Creek," mentions that "Immediately above the Farm of Mr. John W. Coale, along the borders of the creek, we find the valuable property which now belongs to Mr. Wm. T. Easter, who married a daughter of the late Benjamin Silver, Sr. This is believed to be an excellent farm, and well rewards the laborers who properly till the soil. This property is improved by a stone dwelling which has weathered the storms of many a year. We do not know the age of the house, but it is in a very good state of repair. It is a large and commodious building, and Mr. Easter has improved it very much since it came into his possession. He has re-pointed the walls, painted the wood-work and erected a spacious piazza in front, very long and wide, which adds to the beauty as well as to the comfort. Indeed, the dwelling has been so re-juvenated in appearance as to be scarcely recognizable to those who knew it a half century ago. In the days of the writer's early youth, this property was owned and occupied by James Doderill and his wife and daughter."

The 1916 deed reference mentions that farm is commonly known as Wakefield Farm.

The small 1-story wing has a huge cooking fireplace over a large stone hearth under a brick chimney, a door and a window in each side wall.
