DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Glenville Store is a two-section, two-story frame building located on the southwest corner of Harmony Church Road and Glenville Road in the village of Glenville in Harford County, Maryland. The building probably dates from the last quarter of the 19th century.

The southern section, a 1-1/2 story gable-roofed building, was the original store. The gable end faces east toward Glenville Road with a one-story enclosed porch. This was probably once an open porch over the store entrance. The original survey form mentions the porch once had ornamental iron trim. A scroll-sawn bargeboard decorates the eaves.

The residence section adjoins the store on the north, with its gable roof ridge perpendicular to the store's. The three-bay east elevation has a shed entry porch over the center entrance bay. The eaves are not decorated in this part of the building.

The foundation is stone and the clapboard exterior has been covered with aluminum siding. Louvred shutters flank the windows which have modern aluminum sash. The house is now used as a private residence.

Wide eaves have machine-cut decorative wood trim. The front porch once had ornamental iron trim.




