Farm house, simple country version of Victorian style, was owned by one of the Hollingsworth family who owned a prosperous wheel factory on Winters' Plain a mile east. Barelly Hollingsworth ~~that~~ replaced a lean to at the rear and added the kitchen wing within a few years of her marriage in 1885.
