The 1878 Martenet's Map indicates a blacksmith shop in this location, when the farm was owned by William Hopkins of Joseph. The shop may have been here in 1858: Jennings & Herrick Map indicates several buildings around the Mill, all under the label, "Govers Mills". Not many mid-19th century blacksmith shops still stand, although there is a similar stone one on the William Woolsey Farm near Churchville and in Level there is Foard's late 19th century frame shop.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This 1-story, gable roofed rubblestone structure, formerly a blacksmith shop, is located on the northwest side of East Nobles Mill Road.

The structure has board and batten gables and an entrance in the south side, a window in the west end, and a boarded-up opening in the north side. The roof is slate.

Unfortunately the structure is inaccessible and can only be viewed from a distance, so further information is unobtainable.

STATEMENT OF SIGNIFICANCE

The 1878 Martenet's Map indicates a blacksmith shop in this location, when the farm was owned by William Hopkins of Joseph. The shop may even have been here in 1858 when the Jennings & Herrick Map indicates several buildings around the Mill, applying the general label of "Govers Mills" to all of them. Unfortunately, neither the 1866, 1871, or the 1896-97 business directories list any blacksmiths for this area, although there are several listed for the nearby town of Darlington (although none by the name of William Hopkins, J.O. Gorrell, or Wakeman Scott, the various owners of the farm from 1865 until 1897 - the 1896 Directory does list a J.S. Gorrell as a blacksmith in Darlington).

The farm on which this blacksmith shop stands is composed of the two tracts "Bachelors Good Luck" and "Jones Venture". In 1865 William Hopkins of Joseph purchased the 78 acres from Joshua Hopkins, ¹ who had inherited the farm in 1832 from his father, Samuel Hopkins.² William Hopkins' father, Joseph, may have been Joshua's brother, since a mortgage taken out by Joshua on this farm describes the property as being "subject to the life estate of Joseph Hopkins, a lunatic or idiot".³ William Hopkins' heirs owned the farm until 1897, when it was sold to Mary Dickinson.⁴ The adjacent William Hopkins House (HA-332) is on the same farm.

Few mid-19th century blacksmith shops remain in the county, although there is a similar stone one on the William Woolsey Farm near Churchville and Foard's late-19th century frame shop in Level.
