DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Carr-Thomas House is a two-story frame house with a shed porch and a central gable, built about 1880 on the south side of Boyd Road about 1/8 mile east of Ady Road (Maryland Route 543) near Ady, Harford County, Maryland. The main elevation faces west. The house is located at the end of an access drive about 100 yards south of Boyd Road.

The main elevation has three bays with a center entrance. The center gable has a small Gothic-arched window. The shed porch has turned columns and scroll-sawn brackets. The gable ends of the main section have two bays; the south gable end has an irregular window arrangement.

At the rear of the house is a two-story wing with shed additions on the south in the angle between the main section and wing. The foundation is stone and the roof is slate. The original siding was probably clapboard, but is now aluminum. Brick interior end chimneys are located in the main section.

The house may have been a tenant house on the Carr property, which was much larger than the present parcel of the Carr-Thomas House.





