DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two-part structure in two sections, facing eastwards. The northern half is two bays by one, composed of uncoursed stone with quoined corners and stone lintels over the apertures. An entrance with a recently-added door is located on the eastern embrasure. The southern half of the building is vertical frame, with sliding doors on either side, and a gable-flank tin roof encompassing both sections. There are no windows in the frame section, but ~~there~~ in the stone section bear mention. These are board-and-batten hinge shutters, with center panels containing 2 X 2 sashes. The entire building appears to have been converted for storage facilities.

STATEMENT OF SIGNIFICANCE

This former school building is located on parts of tracts called Jerusalem and Rebecca's Lot, most of which were owned by David Lee and Thomas Bond Onion prior to 1800. In 1815, David Preston, who had purchased portions of the beforementioned tracts, conveyed a one-quarter acre lot for the construction of a school to Ralph S. Lee, the son of the founder of Jerusalem Mill, David Lee. The exact date of the construction of this building is unknown, except for the fact that it is post-1815. This "Kellville School" was most likely a private venture, as no mention of it has been made in the various inventories of public schools. Since Ralph Lee owned the land on which the building was erected, one could speculate that it may have served as a company school for the offspring of the employees of Lee's mill and other business ventures.


