DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This stuccoed stone and frame dwelling faces west toward the Jerusalem Mill and appears to represent three differend building periods. It is two and one half stories high, having four gable front dormers of six over six lights on each side of the gable flank, slate covered roof. Three chimneys are present: one at each inside end and one near the center of the roof ridge line.

The main unit of the dwelling is five bays long with its principal entrance in the center bay of the west facade. This has a wide, moulded panel door with a two light transom overhead. Windows on the first elevation are nine lights over six; on the second elevation, six lights over six. All have louvered shutters. The window in the northern most bay of this section has been altered.

The interior of this section is laid out in a classic center through hall floor plan. The stair way is in the south east corner and has a turned newel and handrail, pine treads. Scroll brackets trim the string. A plain fireplace is in the center of the south wall of the south room. In the north room there is also a fireplace. Beaded wainscoting is present in this room. A cut out area in the floor and ceiling appears to have been a circular stairway.

There is a crawl space under the south room and a normal cellar under the entrance hall and the north room. A large stone arch forms a fireplace support. This is approximately 4' 10" high and 5 feet deep. A small stone walled room is in the center of this area.

Section two, the room located north of the main section, is two stories high and one bay wide. This seems to have been a kitchen at one time. A large brick fireplace is in the center of the north wall this has a very plain wood mantle. An iron crane is in the fireplace. There is no cellar under this section. Windows in this section extend above the plastered ceiling. The plaster is rounded at the window frame.

A two story frame addition is located on this house's east side. Its first elevation is a screened in porch while its second elevation provides bedroom space. A one story addition is added to the north side of this section.

This rubblestone structure is two stories high, two bays by one. It has a gable front roof completely covered with ivy. A doorway is located on each level of the north side as well as on the lower level of the south side. A barely visible datestone in the peak of the roof's south side appears to read "1840". This building has a duel purpose-it has a well or trough on the lower level while the upper level was used as a smoke house.

This stone and frame house was the home of miller David Lee in the nineteenth century. Portions of this house seem to date back prior to 1800. The house is concealed by large evergreen trees, which were planted by Ralph Sackett Lee, local lore informs us, to block the view of his daughter's home "The Mound".




